I, BARDWELL D. ODUM, BEING DULY SWORN, MAKE THE FOLLOWING FREE AND VOLUNTARY STATEMENT TO ASSISTANT DIRECTOR HADDELLES.

I HAVE BEEN ADVISED OF AN ALLEGATION THAT LEE HARVEY OSWALD APPEARED IN THE DALLAS OFFICE PRIOR TO THE ASSASSINATION OF PRESIDENT KENNEDY, THAT HE LEFT A NOTE, AND THE NOTE WAS SUBSEQUENTLY DESTROYED.

DURING NOVEMBER, 1963, I WAS ASSIGNED TO THE DALLAS OFFICE OF THE FBI AS A SPECIAL AGENT AND WORKED ALMOST FULL TIME ON THE ASSASSINATION INVESTIGATION AND WAS CLOSELY ASSOCIATED WITH SA JAMES P. HOSTY. DURING THE DAYS AND WEEKS FOLLOWING NOVEMBER 22, 1963, I WAS WORKING ON THE ASSASSINATION INVESTIGATION. I WAS IN DAILY CONTACT WITH JAMES HOSTY AND WITH SPECIAL AGENT IN CHARGE GORDON P. SHANKLIN, AS WELL AS OTHER PERSONNEL OF THE DALLAS OFFICE OF THE FBI. I ALSO INTERVIEWED RUTH PAINE, WITH WHOM MARINA OSWALD WAS RESIDING ON NOVEMBER 22, 1963, ON SEVERAL OCCASIONS.

I DO NOT RECALL EVER HEARING ANYONE STATE OR CLAIM THAT

LEE HARVEY OSWALD HAD EVER BEEN IN THE DALLAS OFFICE OF THE FBI. I DO NOT RECALL ANY CONVERSATIONS WITH RUTH PAINE OR ANYONE ELSE REGARDING SUCH A SUBJECT. UNTIL CERTAIN AGO,ATO NEWSPAPER PUBLICITY ABOUT THIRTY DAYS I HAD NEVER HEARD المعدد ANY REFERENCE MADE TO A NOTE SUPOSEDLY LEFT BY LEE HARVEY OSWALD FOR SA JAMES P. HOSTY. SHE IMMEDIATELY ASKED ME IF SHE AND I HAD EVER TALKED ABOUT LEE HARVEY OSWALD BEING IN THE DALLAS OFFICE OF THE FBI. I TOLD HER THAT I COULD NOT RECALL ANY SUCH CONVERSATION. SHE STATED "I AM GLAD TO HEAR YOU SAY THAT." SHE THEN TOLD ME THAT HUGH AYNESWORTH OF THE DALLAS TIMES HERALD HAD CALLED HER AND ASKED HER ABOUT OSWALD BEING IN THE FBI OFFICE. SHE STATED THAT SHE TOLD AYNESWORTH SHE HAD NEVER HEARD ABOUT HIM BEING IN THE FBI OFFICE IN DALLAS. AYNESWORTH THEN READ WHAT WAS PURPORTED TO HAVE BEEN HER
