**U. S. SENATE SELECT COMMITTEE
TO STUDY GOVERNMENTAL OPERATIONS
WITH RESPECT TO INTELLIGENCE ACTIVITIES (SSC)**

Reference is made to SSC letter dated April 30, 1976, containing a request for access and delivery of certain FBI material relating to the assassination of President John F. Kennedy and plots to kill Cuban Premier Fidel Castro. This memorandum is a partial response to your request.

This memorandum effects access at FBI Headquarters (FBIHQ) by your Staff to material partially responsive to items c, d, and g of referenced request.

This memorandum effects delivery of material responsive to item e.

Review of FBIHQ records on May 5, 1976, failed to disclose any reference regarding item d. This item pertains to access to all files concerning William Burn-Ortega.

On May 4, 1976, Mr. Paul Wallach of the SSC Staff and Mr. [redacted] of this Bureau agreed that item f may be ignored as it repeats item #1 of SSC request dated April 28, 1976.
