At 2:20 pom. I talked with SAC Ghanklin at Dallas relative to the shooting of the President. le stated that, from the informstion .available as of that time, it appears the President has died of lis wounds and that Governor Connolly of Texas is in filer condition. lIfe said that, contrary to prior reports that a üccrot Service man had been killed, this now appears to be untrue.

I told Shanlelin that the Director's specific instructions on this are that we should offer all possible assistance to the Secret Service and to the local police, and that meant just exactly that-mthat we should give all possible assistance. I told him the question of jurisdiction is not pertinent at this time; that while, of course, Secret Service. will regard this as their primary matter, the essential thing is that we offer and give all possible assistance.

II told him there was a report that some spent shells had been round, and he should check and sec whether Secret Service wants us fob send Laboratory men down to assist.

- Hin, Shanklin said that an offer of assistance had already been' wader, and that he had men with the Secret Service, with the Police; Department, and with the Sheriff's Office, and as a matter of fact fad a man at the hospital where airs. Kennedy is. Ilo said that the alleged spot where the shooting took place was from the firth floor of a five-story building on the corner of Film and Commerce streets, and that reportedly a Winchester rifle was used. He said the building is roped off and Secret Service and the police are going through the building. He said reportedly one man had been arrested by the Sheriff's Office but there is nothing definite.

I told Shanklin that if..there is no significant information right now, regarding who did this, we will send out a teletype to all offices to check and account for the whereabouts of members of hate groups in their areas. He advised no one has been identified as yet.

I told Shanklin that if there is a need for any additional manporer he should advise us at once and. it? will be provided. -

Shankinn called back at 2:40 p.m: to advise that a police officer was shot and killed by a (rifle shot in the 500 block of East 10th Street in Dalias, and this is in the same arca as the building where the other shots allegedly were fired. The police have cornered an individual who they feel may have been responsible for the shootings. Shanklin will advise further.

The attachod teletype has been prepared, alerting all offices to immediately contact all informants and sources regarding this shooting and to immediately establish the whereabouts of bombing suspects, Klan and hate group members, racial extremists, and any other individuals who on the basis of information in the files micht have been involved.

## RECOAMENDATION:

If the individual who the police have cornered in Dallas is not the individual responsible for this shooting, it is recommended this teletype go out to all offices at once.

## ADDENDUM:

Shanklin called at 2:55 p.m. to advise that the police have captured the man who is believed to have shot the policeman and the police think he may be the man who killed the president. They tare on their way to the $P D$ and Shankin will report as zoon' as he gets the facts.
