According to the information we received concerning the possibility that Oswald had been at Wytheville, Virginia, at the Red Cross Station seeking assistance to go to Princeton, West Virginia, the following was determined:

Mrs. Frank Nelms, American Red Cross representative, who is nearly eighty years old and rambles in her conversation, advised that an individual using the name of Oswald had sought assistance in traveling to Princeton, West Virginia. She stated that the man resembled newspaper photographs of Lee Harvey Oswald, that he had heavy, dark eyebrows and lashes and was slender. He spoke of being married to a Russian girl and that his family lives near Dallas, Texas. He seemed foreign in appearance and had an unknown foreign accent. When she called the Greyhound Bus Terminal to secure food and transportation, he then said his name was Henry Richards. She did not question him concerning the difference in the names used.

Bob Puckett, Greyhound Bus Terminal, exhibited a slip of paper indicating one Henry Richards received a bus ticket and lunch from Salvation Army funds. Richards made mention of the fact that he had a sister in Princeton, and that he was going to visit her and then planned on going to Texas but did not state that he had any relatives there.

Puckett described Mrs. Nelms as an elderly lady who has difficulty in recalling time and events.

Oswald is not known to have any relatives in Princeton, West Virginia, and is not known to have left Dallas, Texas, during the last two months.
