OF PHOENIX FILE ONE HUNDRED DASH FIVE FOUR ONE SEVEN. JEFFERS  
WELL KNOWN TO BUREAU AS BEING SUBJECT OF CASES UNDER SUCH  
CHARACTERS AS [REDACTED], [REDACTED], [REDACTED], AND [REDACTED]

[REDACTED]. JEFFERS PURPORTS TO BE HEAD  
OF THE KINGDOM OF YAHWEH, INC., PHOENIX, AND RESIDES IN PHOENIX.

ON NOVEMBER FOUR FIFTYNINE, THE BUREAU ADVISED THAT JOSEPH  
AND HELEN JEFFERS HAD OPERATED IN VARIOUS CITIES IN U. S. AND  
HAVE DISSEMINATED PSYCHIC READINGS AND PREDICTIONS UNDER  
THE NAME OF QUOTE THE KINGDOM OF YAHWEH END QUOTE. QUOTE  
KINGDOM VOICE END QUOTE IS THE PUBLICATION OF THIS ORGANIZATION.

JEFFERS FIRST CAME TO THE ATTENTION OF BUREAU IN NINETEEN THIRTYEIGHT WHEN A COMPLAINT WAS RECEIVED HE HAD [REDACTED]

[REDACTED] IN FIFTYFIVE, HE WAS CONVICTED OF [REDACTED] AND SENTENCED TO [REDACTED]

[REDACTED] WHILE IN PRISON HIS WIFE CARRIED ON THE ACTIVITIES OF HIS QUOTE KINGDOM ON TEMPLE END QUOTE. JEFFERS WAS PAROLED IN FORTYSIX., HOWEVER HIS PAROLE WAS REVOKED IN FORTYSEVEN BECAUSE HE HAD AGAIN BEEN [REDACTED]

[REDACTED] SINCE HIS RELEASE IN FORTYNINE, HE AND HIS WIFE HAVE BEEN SUBJECTS OF NUMEROUS COMPLAINTS CONCERNING THEIR [REDACTED]

III MAY SIXTYTWO, JEFFERS WAS REPORTEDLY OBSERVED ON SEVERAL OCCASIONS AT DOG RACE TRACK, PHOENIX, GAMBLING HEAVILY. IN AUGUST SIXTYTWO, U. S. POSTAL INSPECTOR, PHOENIX, STATED THEY WERE INVESTIGATION TO SEE IF JEFFERS WAS IN VIOLATION OF ANY OF THE MAIL FRAUD STATUES AND FELT THEY MAY HAVE A GOOD CASE AGAINST JEFFERS.

NO FURTHER ACTION BEING TAKEN BY PHOENIX.
