HOWEVER, THIS FLIGHT WAS CANCELLED BECAUSE OF A HURRICANE
OVER THE GULF AREA. HE LEFT NEW ORLEANS AT APPROXIMATELY
SEVEN P.M., ON SEPTEMBER SEVENTEEN, SIXTYTHREE, THE FLIGHT
AND AIRLINES NOT RECALLED, AND FLEW DIRECTLY, NON-STOP
TO MEXICO CITY, MEXICO. HE STAYED AT THE MONTE CASSINO HOTEL
