TOM POWERS, CHICAGO TRIBUNE, ADVISED SAC THIS DATE ONE OF HIS PHOTOGRAPHERS HAD BEEN ADVISED ANONYMOUSLY, CHICAGO PD ARRESTED LEE HARVEY OSWAULD UNDER ASSUMED NAME ELEVEN TWO LAST WITH RIFLE. THIS INDIVIDUAL ALLEGEDLY APPEARED IN JUDGE KOWALSKI/S COURT. INVESTIGATION CONDUCTED THIS DATE AT CHICAGO, REFLECTS THAT NO RECORD IS ON FILE IN THE RACKETS COURT, BRANCH TWENTYSEVEN, CHICAGO PD, COVERING JUDGE KOWALSKI/S COURT REGARDING INDIVIDUAL MENTIONED IN ANONYMOUS CALL. INVESTIGATION REFLECTS, HOWEVER, THE ARREST OF ONE THOMAS VALLEE, DESCRIBED AS WHITE MALE, THIRTY YEARS OF AGE, RESIDENCE FOUR SIX ONE FOUR NORTH PAULINA, CHICAGO, ON ELEVEN TWO SIXTYTHREE AT NINE AM. INVESTIGATIIG OFFICERS, DETECTIVE LAWRENCE COFFEY AND DETECTIVE JAMES

MADDERN ADVISE THOU S VALLEE WAS UNDER SUSPICION BY SECRET SERVICE INVESTIGATORS REGARDING THE PLANNED ARRIVAL OF PRESIDENT KENNEDY, ELEVEN TWO SIXTYTHREE FOR ARMY DASH AIRFORCE GAME IN SOLDIERS FIELD. OFFICERS OF CHICAGO PD PLACED A SURVEILLANCE ON VALLEE AND ARRESTED HIM NINE AM ELEVEN TWO SIXTYTHREE FOR MAKING WRONG TURN. FOUND IN VALLEE/S POSSESSION WAS A KNIFE, AND SUBSEQUENT SEARCH OF HIS HOME RESULTED IN DISCOVERY OF TWENTYFIVE HUNDRED ROUNDS OF RIFLE AMMUNITION ALONG WITH M ONE FIFLE AND CARBINE RIFLE. VALLEE APPEARED IN JUDGE KOWALSKI/S COURT ELEVEN FOUR SIXTYTHREE, CASE WAS CONTINUED UNTIL ELEVEN TWENTYSIX SIXTYTHREE AND ON ELEVEN TWENTYSIX SIXTYTHREE, VALLEE APPEARED WITH COUNSEL AND CASE WAS CONTINUED TO ONE TWENTYSIX SIXTYFOUR. VALLEE DEFINITELY DETERMINED TO BE NOT IDENTICAL WITH OSWALD AND NO OTHER LIKELY POSSIBLTY APPEARS FROM A SEARCH OF JUDGE KOWALSKI/S DOCKET RECORD.

ON ELEVEN TWENTYSIX SIXTYTHREE A SEARCH WAS MADE OF ALL POLICE RECORDS, CHICAGO PD, AND THERE WAS NO RECORD OF OSWALD/S ARREST.
