RELR TELCALL TO DALLAS TODAY.

CHARLES HUBBARD, DISTRICT MANAGER, SOUTHWESTERN BELL TELEPHONE COMPANY, FORT SMITH, ARKANSAS, ADVISED TODAY THAT AT THREE THIRTYFIVE PM TODAY, OPERATOR, MRS. MARGRET J. SMITH, RECEIVED TELEPHONE CALL FROM UNKNOWN MALE CALLER, CALL MADE FROM LOCAL PAY STATION, AND THE CALLER SAID, QUOTE REGARDING THE DEATH OF THE PRESIDENT, CONDUCT INVESTIGATION AT THE BUCKHORN BAR, DALLAS, AS THE MANAGER HAS BEEN TALKED TO ABOUT THE KILLING. FOLLOWING INFO WAS FURNISHED BY SISTER MARY KEVIN,
 ST. JOSEPH'S ORPHANAGE, NORTH LITTLE ROCK, ARKANSAS, THIS
 AFTERNOON. SHE PICKED UP RECEIVER TO MAKE TELCALL BETWEEN
 TWELVE FORTY AND TWELVE FORTYFIVE PM TODAY. AFTER DIALING
 THREE DIGITS. HEARD CLEAR VOICE ON LINE, STOPPED DIALING,
 AND HEARD THE NAME PAUL MENTIONED. SHE HUNG UP AND WENT
 INTO ADJOINING ROOM TO ASK SISTER MARY CYRILLA IF THE LINE
 WAS BUSY. REPLY WAS NEGATIVE. SISTER CYRILLA THEN PICKED
 UP PHONE IN HER OFFICE AND SISTER KEVIN LISTENED ON THE
 FIRST LINE, AND THEY BOTH HEARD A VOICE SAY QUOTE FIFTYONE
 UNQUOTE, A PAUSE, THEN QUOTE WAIT JUST A MINUTE UNQUOTE
 A YOUNG WOMAN WAS THEN HEARD TO SAY QUOTE HELLO DADDY
 UNQUOTE. A MAN REPLIED QUOTE WE HAVE BEEN WAITING TO HEARD
 FROM YOU UNQUOTE. THE WOMAN THEN SAID QUOTE THE PRESIDENT
 WAS SHOT UNQUOTE. THE MAN SEEMED TO REPLY IMMEDIATELY
 QUOTE THAT IS ALL WE NEED TO KNOW UNQUOTE. THE WOMAN THEN
 SAID QUOTE THE GOVERNOR OF TEXAS WAS SHOT, TOO, UNQUOTE.
 BOTH SISTERS THEN HUNG UP. SISTER CURILLA VERIFIED ABOVE
 IN DETAIL.
