ASSASSINATION OF PRESIDENT KENNEDY.

REBUTEL TO SAN ANTONIO AND DALLAS.

WILLIAM CHAMBERS, OIC, US INS, DEL RIO, ADVISED CALL RECEIVED AT DEL RIO TELEPHONE NUMBER SEVEN SEVEN FIVE DASH TWO EIGHT THREE FOUR BETWEEN TWO AND THREE PM, NOVEMBER TWENTYSECOND LAST AND ANSWERED BY HIS SECRETARY WHO STATED CALL WAS DIRECT AND NO OPERATOR INTERVENED. MAN INQUIRED AS TO WHETHER CARS STILL PERMITTED INTO MEXICO. SECRETARY SWITCHED CALL TO CHAMBERS AND IN CONSERVATION MAN ASKED IN VIEW OF WHAT HAD HAPPENED, APPARENTLY REFERRING TO ASSASSINATION, IF HE COULD STILL ENTER MEXICO AND INDICATED HE WAS IN FT. WORTH AND DID NOT WANT TO MAKE FOUR HUNDRED MILE TRIP IF BORDER WAS CLOSED.
