[REDACTED] ENRICO AARON DE DUSSELDORF, HAD BEEN HEARD TO STATE
 THAT AFTERNOON HE KNEW OF A PLAN TO ASSASSINATE PRESIDENT KENNEDY AND
 VICE PRESIDENT JOHNSON WHICH WAS TO HAVE TAKEN PLACE IN TAMPA NOVEM-
 BER EIGHTEEN BUT WAS NOT ACCOMPLISHED BECAUSE OF A FLUKE. TEXAS

DUSSELDORF INTERVIEWED, IDENTIFIED SELF AS HENRY EDWARD SCOTT,
 BORN AUGUST FIVE, NINETEEN THIRTYSIX IN SAN SALVADOR, EL SALVADOR
 CLAIMS DUAL CITIZENSHIP OF U. S. AND SALVADOR AS FATHER, HUGH ANDREA
 SCOTT, IS U. S. CITIZEN.

SCOTT CLAIMS SERVED USAF OCTOBER TWENTYONE, NINETEEN FIFTYFOUR,
 TO DECEMBER TWENTYNINE, FIFTYFIVE, AFSN ONE FOUR FIVE FIVE ONE FOUR
 ZERO NINE. CLAIMS HE AND FATHER DO NOT GET ALONG AND HE INTENDS TO
 ACCOMPLISH LEGAL CHANGE OF NAME TO DUSSELDORF, WHICH WAS HIS MOTHER-S
 MAIDEN NAME. SCOTT DENIES ANY KNOWLEDGE OF ASSASSINATION PLOT, SAYS

HE TOLD [REDACTED] HE DOES NOT BELIEVE LEE OSWALD WAS THE KILLER AND THAT IF ANYONE HAD WANTED TO SHOOT THE PRESIDENT IN TAMPA THERE WERE AMPLE OPPORTUNITIES WHILE MOTORCADE TRAVERSED TAMPA STREETS.

AGENTS EXAMINING SCOTT-S IDENTIFICATION PAPERS OBSERVED SMALL SLIP OF PAPER IN PLEXIGLAS CONTAINER FOR SOCIAL SECURITY CARD WHICH BORE HANDWRITTEN NAME AND ADDRESS RAYMOND E. HARRELL, THREE TWO TWO FIVE ROCK BLUFF, DALLAS TWENTYSEVEN, TEXAS. SCOTT AT FIRST CLAIMED HE DID NOT REMEMBER HARRELL, THEN RECALLED HE IS MAN WHO CONTACTED HIM IN LAREDO, TEXAS, ABOUT NINETEEN FIFTYSEVEN SEEKING TO BUY SOME MEXICAN CHIHUAHUA DOGS. SCOTT HAS RESIDED TAMPA SINCE FALL NINETEEN SIXTY, IS EMPLOYED AS TAXI DRIVER BY YELLOW CAB COMPANY, HEIGHT FIVE FEET ELEVEN INCHES, ONE FIFTY LBS., SLENDER, BROWN HAIR, HAZEL EYES.

[REDACTED] CHARACTERIZED SCOTT AS QUOTE LOUDMOUTH TYPE WHO HAS VERY VOCAL OPINIONS ON EVERY SITUATION END QUOTE. [REDACTED]

[REDACTED] APARTMENT HOUSE, SAYS SCOTT HAS TENDENCY TO QUOTE TALK OFF TOP OF HIS HEAD END QUOTE WHEN HE REALLY KNOWS NOTHING.

DALLAS IDENTIFY HARRELL AND DETERMINE WHETHER POSSIBLY INVOLVED IN ASSASSINATION PLCT.

IF RESULTS DALLAS INVESTIGATION INDICATE DESIRABILITY OF POLY-GRAPH EXAMINATION OF SCOTT, ADVISE TAMPA WHO WILL REQUEST BUREAU AUTHORITY.
