RE EL PASO TELETYPE TO BUREAU NOVEMBER TWENTYTHREE LAST WASHINGTON FIELD TELETYPE TO BUREAU NOVEMBER TWENTYFOUR LAST AND EL PASO TELETYPE TO BUREAU NOVEMBER TWENTYFIVE LAST.

FOR INFORMATION CHARLOTTE AND SAN FRANCISCO, RE EL PASO TELETYPE NOVEMBER TWENTYTHREE LAST ADVISED U. S. ARMY ENLISTED MAN BY NAME OF QUIROGA, NOT FURTHER IDENTIFIED, REPORTEDLY MADE STATEMENT ON MEXICAN SIDE OF U. S. - MEXICAN BORDER ABOUT FIVE THIRTY P. M. NOVEMBER TWENTYTWO LAST TO EFFECT QUIROGA HAD BEEN IN DALLAS PREVIOUS EVENING AND KNEW ASSASSINATION WAS TO TAKE PLACE. THIS STATEMENT ALLEGEDLY MADE IN PRESENCE OF LARGE GROUP OF PERSONS WAITING TO RETURN TO UNITED STATES BUT BEING DETAINED DUE TO FACT BORDER TEMPORARILY CLOSED.
