ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, ELEVEN TWENTY TWO SIXTY THREE , DALLAS , TEXAS.

ON ELEVEN TWENTY SIX SIXTY THREE , MORRIS ROSENTHAL, SEVENTY FOUR GERALD AVE. BROCKTON , MASS. AND HIS WIFE MARIE , A SCHOOL TEACHER IN WEST BRIDGEWATER , MASS., ADVISED THAT HER SON BY A PREVIOUS MARRIAGE , JOHN P. SULLIVAN , JR. , HAD WORKED IN GERMANY LAST SUMMER. EN ROUTE HOME IN SEPTEMBER , NINETEEN SIXTY THREE , HE MEET A MAN AND WOMEN IN GLOSCOW , SCOTLAND WHO SAID THEY WERE FROM TEXAS. WHEN THEY HEARD HE WAS FROM BOSTON , MASS.

AREA THEY SAID HE WAS FROM KENNEDY COUNTRY AND THAT KENNEDY HAD BETTER NOT COME TO TEXAS AS THEY WOULD PUT A BULLET INTO HIM.

JOHN F. SULLIVAN , JR. , A SENIOR AT PROVIDENCE COLLEGE, PROVIDENCE , RHODE ISLAND , ADVISED ON ELEVEN TWENTY SIX SIXTY THREE THAT HE ROOMS AT THE HOME OF MRS. MICHAEL J. MC GUIRE ONE ZERO SIX EATON STREET , PROVIDENCE , RHODE ISLAND . HE STATED THAT HE HAD GONE TO GERMANY LAST SUMMER AS HE HAD

OBTAINED A JOB AS A BARTENDER THROUGH THE AMERICAN STUDENT INFORMATION SERVICE . EN ROUTE HOME ON FRIDAY , SEPTEMBER

THIRTEEN LAST . HE WAS IN GLOSCOV , SCOTLAND AND MET IN A CASUAL FASHION AN AMERICAN COUPLE WHO DESCRIBED THEMSELVES AS MAN AND WIFE FROM TEXAS . WHEN HE MENTIONED THAT HE WAS FROM THE BOSTON , MASS. , AREA THEY TALKED ABOUT PRESIDENT KENNEDY AND STATED THAT SOMEONE OUGHT TO SHOOT HIM . WHEN THEY MADE THIS REMARK THEY WERE LAUGHING AND JOHN SULLIVAN ADVISED THAT HE BELIVED THAT THEY HAD MADE THE REMARK IN JEST AND DID NOT MEAN IT .

SULLIVAN STATED THAT THIS CONVERSATION WITH THESE PEOPLE LASTED NO MORE THAN TWO OR THREE MINUTES . AT NO TIME WAS HE INTRODUCED TO THEM AND DID NOT KNOW EITHER THEIR OR LAST NAMES. THEY DID NOT INDICATE WHERE THEY WERE STAYING IN SCOTLAND NOR WHERE THEY CAME FROM IN TEXAS .

PP3 SULLIVAN DESCRIBED THESE INDIVIDUALS AS FOLLOWS:

MAN WHITE MALE THIRTY FIVE TO FORTY YEARS OF AGE, SIX FEET
ONE INCH IN HEIGHT, SLENDER BUILD, ONE HUNDRED SIXTY POUNDS
AND WORE A LOUD SPORT SHIRT AND DARK PANTS. WIFE WHITE
FEMALE, SLENDER BUILD, FIVE FEET FOUR INCHES IN HEIGHT, ONE
HUNDRED TEN POUNDS AND WORE A BEIGE COLORED DRESS WITH DARK
BROWN COLORED PRINT.
