ASSASSINATION OF PRESIDENT KENNEDY, NOVEMBER TWENTYTWO, NINETEEN SIXTY
THREE, DALLAS, TEXAS.

RE SALT LAKE CITY TEL THIS DATE.

RE CHURCH OF THE FIRST BORN OF THE FULLNESS OF TIME /CFB/.

NO REFERENCE TO CFB IN EL PASO OFFICE FILES. JOEL AND ERVAL
LE BARON, MENTIONED IN RE TEL, POSSIBLY IDENTICAL WITH JOEL FRANKLIN
LE BARON, BUFILE TWENTY FIVE - TWO SIX FOUR THREE TWO ONE, AND ERVIL
MORREL LE BARON, BUFILE TWENTY FIVE - TWO SIX EIGHT FOUR FIVE FOUR,
BOTH OF WHOM, ALONG WITH THEIR BROTHER, ALMA DAYER LE BARON, TWENTY
FIVE - TWO FOUR NINE SEVEN SEVEN SIX FLED U. S. IN NINETEEN FORTYFOUR
TO EVADE DRAFT AND WENT TO MEXICO. JOEL SURRENDERED SELF AT EL PASO
IN NINETEEN FORTYEIGHT, PLED GUILTY TO DRAFT EVASION CHARGE, SENTENCED
TO ONE YEAR, SUSPENDED FOR THREE YEARS. ERVIL AND ALMA NEVER KNOWN
TO HAVE RETURNED TO U. S. IN OCTOBER, NINETEEN SIXTY, DR. E. L. HATCH,
COLONIA JUAREZ, CHIHUAHUA, MEXICO, A MORMON, SAID LE BARON BROTHERS,
WERE THEN RESIDING COLONIA JUAREZ, LOCATED ABOUT ONE HUNDRED
SEVENTYFIVE MILES SOUTHWEST OF EL PASO.

DR. CLARK S. KNOWLTON, SOCIOLOGY DEPT., TEXAS WESTERN COLLEGE, EL PASO, A MORMON, SAID HEADQUARTERS CFB LOCATED GALEANA, CHIHUAHUA, MEXICO, NEAR COLONIA JUAREZ. CFB MEMBERS PRACTICE POLYGAMY, WHICH MAKES LIVING IN U. S. DIFFICULT. KNOWLTON HAS BEEN TOLD BY MEMBER OF CFB THAT MOST CFB MEMBERS HAVE LEFT EL PASO AREA AND THAT LE BARON BROTHERS ARE NO LONGER LEADERS OF CFB. KNOWLTON SAID CFB SEEMS TO BE VERY UNSTABLE, NEW MEMBERS REMAINING AS MEMBERS ONLY A SHORT TIME. KNOWLTON DID NOT KNOW OF ANY PLOTTING BY CFB AGAINST GOVERNMENT OFFICIAL AND DID NOT BELIEVE THEM TO BE THAT STUPID. SAID MASTERS THESIS RE CFB HAS BEEN WRITTEN, WHICH CAN BE OBTAINED FROM DR. RICH, RELIGION DEPT., BRIGHAM YOUNG U. BISHOP M. PRATT AND EL PASO STAKE PRESIDENT, LIONEL M. WEST, GENERALLY CONFIRMED KNOWLTONS STATEMENTS. NO FURTHER ACTION BEING TAKEN BY EL PASO OFFICE RE CFB, UACB.
