

CHAMBERS, MANAGER, ARMOUR PROPERTIES, OIL AND GAS BUILDING, WICHITA FALLS, TEXAS INTERVIEWED AND FURNISHED NO ADDITIONAL PERTINENT INFORMATION AND ADVISED THAT HE HAS NOT PERSONALLY HEARD HILL MAKE THE TYPE OF STATEMENTS WHICH RELATED THAT HILL HAD MADE. CHAMBERS DID SAY THAT HE TALKED WITH ON TODAY, CONCERNING THIS MATTER AND CHAMBERS ADVISED AT THIS TIME HE HAD APPARENTLY MIS AS TO THE EXACT WORDING OF HILL-S CONVERSAT UNDERSOOD AND THE DATES OF HILL-S CONVERSATION. ON TODAY, TEXAS, ADVISE HE HAS KNOWN JOHN HILL, PRESIDENT OF SOUTHWEST PRODUCING COMPANY, DALLAS, TEXAS, APPROXIMATELY SEVEN OR EIGHT YEARS, KNOWN HIM WELL THE LAST THREE OR FOUR YEARS ADVISED THAT ABOUT EIGHT MONTHS TO ONE YEAR AGO, HE AND MRS. ACCOMPANIED MR. AND MRS. JOHN HILL TO DRINKS, HILL BEGAN A VERY VICIOUS VERBAL ATTACK ON PRESIDENT END PAGE ONE 22 DEC 8 1963 ROBER -SHLD BE ROCER

KENNEDY. HILL CRITICIZED WHAT THE PRESIDENT WAS DOING TO THE COUNTRY AND BLAMED KENNEDY FOR BRINGING COMMUNISTS AND THE SOCIALISTS INTO THE GOVERNMENT AND STATED KENNEDY HAD SAID OIL WAS ONE DOLLAR PER BARREL TOO HIGH. SAID HILL DURING THE CONVERSATION SAID "YOU/D BETTER DO SOMETHING TO GET THIS STOPPED BECAUSE I KNOW SEVERAL OILMEN WHO HAVE WHAT IT TAKES TO HAVE THE PRESIDENT ASSASSINATED". THE STATED HILL KNOWS THAT HE AND ARE STRONG DEMOCRATS AND THAT WERE KNOWS PRESIDENT LYNDON B. SAID HE WAS VERY SHOCKED BY HILL'S TALK. JOHNSON. ADVISED HE TOLD HILL THAT HIS TALK ABOUT THE PRESIDENT WAS A FEDERAL VIOLATION. STATED THAT AND MRS. HI LEFT THE TABLE AND HILL STATED HE COULD NOT HELP IT IF HE HAD AND INSISTED HE WAS NOT KIDDING. UPSET STATED HILL IS A VERY LARGE MAN, CAN HOLD LARGE AMOUNTS OF LIQUOR AND WAS NOT DRUNK WHEN HE MADE THESE STATEMENTS. FURTHER ADVISED HILL STATED THAT HE HAD COMPLETELY SWITCHED FROM THE DEMOCRATIC PARTY TO THE OTHER SIDE BECAUSE OF WHAT HE, HILL, HAD STATED HE HAD THE PERSONAL MEETINGS FOUND OUT. WITH HILL IN DALLAS SINCE THE ABOVE INCIDENT. STATED THE LAST OF THESE MEETINGS WAS LAST AND ON EACH OF THESE MEETINGS HILL ASKED IF HAD DONE ANYTHING ABOUT GETTING END PAGE TWO
