ASSASSINATION OF PRESIDENT KENNEDY, NOV. TWENTYTWO, SIXTYTHREE, DALLAS TEXAS. MISCELLANEOUS - INFORMATION CONCERNING. PAREN SECRET SERVICE MATTER PAREN.

JOHN F. LINDAHL
JOHN H. LINDAHL, SALESMAN, COLGATE, PALMOLIVE, PEET CO., MILWAUKEE, WISC, ADVISED THIS DATE THAT ON NOV. TWENTY LAST WHILE SPENDING NIGHT AT HOLIDAY INN, DE KALB, ILL., LOCATED ON ROUTE ALTERNATE THIRTY HE WAS IN COCKTAIL LOUNGE BETWEEN ELEVEN FIFTEEN P.M. AND TWELVE MIDNIGHT. DURING THIS TIME UNKNOWN MAN AGE APPROXIMATELY FORTYFIVE, CAUCASIAN RACE, BROWN CURLY HAIR, APPROXIMATELY FIVE FT. TEN IN. TO SIX FT. TALL, WEIGHT ONE HUNDRED SIXTYFIVE LBS., LIGHT COLOR COMPLEXION, UNUSUALLY LOUD VOICE, WHO WAS KNOWN TO BE RESIDING IN ROOM ONE ZERO FOUR AT HOLIDAY INN, ENGAGED IN EXTENSIVE DISCUSSION CONCERNING A LEADER HAVING BEEN ASSASSINATED IN LAOS. UNSUB THEN SAID, QUOTE, THIS IS WHAT WE SHOULD DO HERE, DASH, KILL HIM, UNQUOTE. THIS REMARK DEFINITELY REFERRED TO THE PRESIDENT OF THE U.S. UNSUB WAS ADMONISHED BY THE CROWD THAT SUCH REMARKS SHOULD NOT BE MADE.

UNSUB THEN REMARKED TO THE EFFECT, QUOTE, THIS IS WHAT IS GOING TO HAPPEN, DASH, JUST YOU WAIT AND SEE, UNQUOTE.

LINDAHL STATED THE BARTENDER WAS HAVING DIFFICULTIES WITH UNSUB. NAME OF BARTENDER NOT KNOWN BUT DESCRIBED AS BEING UNUSUALLY BIG MAN AND UNUSUALLY TALL. LINDAHL OBSERVED UNSUB WAS APPARENTLY UNDER INFLUENCE OF ALCOHOL BUT IN VIEW OF HIS ADAMANT ATTITUDE AND DEVELOPMENTS HE CONSIDERED THIS MATTER SHOULD BE REPORTED.

ALSO PRESENT IN COCKTAIL LOUNGE WAS UNKNOWN INDIVIDUAL REFERRED TO AS DOCTOR ACCOMPANIED BY UNKNOWN WOMAN, AND TWO OTHER UNKNOWN MEN, ONE OF WHOM WAS KNOWN TO LINDAHL TO BE A SALESMAN WITH CHAMPION SPARK PLUG CO.

ABOVE INFORMATION ORALLY SUPPLIED TO JOHN SOKOLL, ASST. AGENT IN CHARGE, SECRET SERVICE, MILWAUKEE, WIS., DURING TIME COMPLAINANT BEING INTERVIEWED INSTANT DATE. COMPLAINANT IMMEDIATELY PROCEEDED TO OFFICE OF SOKOLL TO RELATE DETAILS FIRST HAND. CONFIRMATION OF INFORMATION BEING SUPPLIED TO SECRET SERVICE LOCALLY IN WRITING.

SAC, CHICAGO, TELEPHONICALLY SUPPLIED ABOVE INFORMATION FOR CONSIDERATION IN ASSISTING SECRET SERVICE. BEING SUPPLIED DALLAS
