NYO HAS VERIFIED WHEREABOUTS ON ELEVEN TWENTY TWO SIXTY THREE IN NEW YORK OF FOLLOWING MEMBERS OF HATE GROUPS IN NEW YORK AREA WHO ARE SUBJECTS NYO COLON LUKE DOMMER OF NATIONALIST PRITY., GEORGE LINCKE OF AMERICAN NAZI PARTY OF NEW YORK, JAMES MADOLE OF NATIONAL RENAISSANCE PARTY, TONY WELLS OF AMERICAN NAZI PARTY AND WILLIAM HOFF OF NATIONAL STATES RIGHTS PARTY.
