INFO HAS BEEN RECEIVED FROM LOCAL LAW ENFORCEMENT AGENCIES
 NATCHEZ, MISSISSIPPI OF A POSSIBLE KLAN- TYPE ORGANIZATION AT NATCHEZ.
 DOUGLAS A. BYRD, NATCHEZ, MISS., HAS BEEN IDENTIFIED BY SOURCES AS
 BEING ACTIVE IN ORGANIZING KLAN- TYPE GROUPS IN OTHER AREAS OF
 MISSISSIPPI. BYRD OBSERVED BY OFFICER NATCHEZ PD AT NATCHEZ BETWEEN
 TEN THIRTY AND ELEVEN AM TODAY AND AT THREE THIRTY PM COP NATCHEZ
 ADVISED THAT BYRD HAD JUST LEFT PLACE OF EMPLOYMENT AT
 NATCHEZ. BYRD PERSONALLY OBSERVED BY BUAGENT AT NATCHEZ AT FOUR
 THIRTY EIGHT PM. CLAUDE DAVIS, ALSO OF NATCHEZ, IDENTIFIED BY SOURCES
 AS KLAN MEMBER ACTIVE IN RECRUITING. DAVIS SELF EMPLOYED SELLING
 HOUSEWARE IN AREA OF EASTERN LA. DAVIS LEFT NATCHEZ ON NOV. TWENTY
 ONE LAST AND ATTEMPTS BEING MADE TO ASCERTAIN WHEREABOUTS ON
 NOV. TWENTY TWO. HUNT OIL COMPANY HAS NO OPERATIONS AT NATCHEZ HOWEVER
 HAS OPERATIONS IN CATAHOULA AND CONCORDIA PARISHES, LA., ADJACENT
 TO NATCHEZ AND HAS ONE HUNDRED TWENTY FIVE EMPLOYEES IN AREA OF
 EASTERN, LA.
