[REDACTED] HAS BEEN INTERVIEWED AT BIRMINGHAM ON SEPTEMBER TWENTYSEVEN, SIX THREE, AND ON OCTOBER THIRTYONE, SIX THREE, AT WASHINGTON, D. C. DURING INTERVIEWS [REDACTED] ADVISED HE IS NOT A MEMBER OF THE NSRP OR ANY KLAN OR HATE-TYPE ORGANIZATIONS. HE HAS ADMITTED ASSOCIATION WITH VARIOUS INDIVIDUALS CONNECTED WITH NSRP AND KLAN ORGANIZATIONS. HE HAS ALSO INDICATED OPPOSITION TO ANY VIOLENCE TYPE ACTION. HE HAS BEEN EMPLOYED BY THE NSRP AT BIRMINGHAM, ALABAMA, FROM MARCH SIX THREE UNTIL JUNE SIX THREE
