ON NOVEMBER TWENTYFIVE INSTANT WILLIAM BUNGE, EMPLOYMENT  
MANAGER, EKCO PRODUCTS COMPANY, ONE NINE FOUR NINE NORTH  
CICERO AVENUE, CHICAGO, ADVISED SAS GAROLD R. FITZGERALD  
AND LOREN G. ADAMS THAT COY HOOD EMPLOYED THAT PLANT DID  
NOT WORK ON NOVEMBER TWENTYTWO SIXTYTHREE DUE TO ILLNESS.

HOOD IN INTERVIEW NOVEMBER TWENTYFIVE INSTANT AT THREE  
TWO FIVE SOUTH KILPATRICK AVENUE BY ABOVE AGENTS EXPLAINED  
THAT DURING THURSDAY NOVEMBER TWENTYONE LAST SHIFT HE  
INJURED RIGHT EYE BY GETTING STEEL PARTICLE IN EYE. HE  
WAS SENT HOME AND INSTRUCTED TO CONTACT A DOCTOR. HOOD  
EXHIBITED BILL FOR MEDICAL CARE TO EYE IN AMOUNT TEN DOLLARS  
NOVEMBER TWENTYONE LAST FROM DR. JAMES D. WALSH, TWENTYEIGHT

TWELVE NOON THURSDAY AND SPENT REST OF THURSDAY AND ALL DAY  
FRIDAY RELAXING AT HOME, HAVING BEEN SENT HOME ON FRIDAY FROM WORK  
DUE TO EYE INJURY.

~~OSCAR SAGIE~~ FOUR EIGHT THREE ONE WEST COBURN  
STREET, CHICAGO, SUPERVISOR OF ABOVE, ADVISED ON NOVEMBER  
TWENTYFIVE INSTANT THAT HOOD HAD REPORTED FOR WORK ON FRIDAY  
AS STATED AND WAS SENT HOME BECAUSE HIS EYE WAS STILL BANDAGED  
AND HE WAS IN NO CONDITION TO WORK. HE STATED HOOD RETURNED  
TO WORK TWELVE ZERO ONE AM SHIFT NOVEMBER TWENTYFIVE INSTANT..

CHESTER BREWINGTON, THREE TWO FIVE SOUTH KILPATRICK  
STREET, CHICAGO, ILL, ADVISED ABOVE AGENTS THAT HE OBSERVED HOOD AT THE  
ABOVE ADDRESS ON FRIDAY, NOVEMBER TWENTY TWO, AT BETWEEN  
TWO FORTY FIVE PM AND THREE PM. BREWINGTON SAID THAT HOOD  
AT THAT TIME WAS STILL SUFFERING FROM THE INJURY TO HIS EYE.  
HE RECALLED THAT HOOD HAD SAID THAT HE HAD BEEN SLEEPING AND RESTING  
HIS EYE DURING MOST OF THAT DAY.

LEON FLICHUM, ALSO THREE TWO FIVE SOUTH KILPATRICK, ROOMMATE  
OF BREWINGTON, ADVISED HE OBSERVED HOOD AT FOUR PM, NOVEMBER  
TWENTYTWO, WHEN HE, FLICHUM RETURNED FROM WORK.
