IS IT POSSIBLE TO TRANSMIT A CONFIDENTIAL MESSAGE TO MR. J. EDGAR HOOVER ON THIS CONNECTION OR WOULD YOU PREFER TO CALL ME FROM ANOTHER MACHINE--MY MESSAGE IS ON TAPE WITHOUT A HEADING OR SIGNATURE, BUT IS INTENDED FOR MR. HOOVER PERSONALLY OR A MEMBER OF HIS CONFIDENTIAL STAFF. GA PLS

GA AND SEND MESSAGE ON THIS MACHINE

AFTER READING IN THE MORNING PAPERS THAT THE RUSSIANS HAVE TURNED OVER TO YOU THE "CONSULAR FILE" ON OSWALD, THE EVENTS ORIGINATING IN RUSSIA AND THOSE IN ADDITION HAVING CHARACTERISTICS MAKING THEM APPEAR AS POSSIBLY RUSSIAN CONNECTED, I HAVE BEGUN TO FEEL A FAIRLY STRONG SUSPICION THAT THERE IS MORE TO THE OSWALD-RUBY CASE THAN SIMPLE INDIVIDUAL ACTS ON THE PART OF THE TWO MEN.

CERTAINLY, WE CAN AGREE THAT THE RUSSIANS HAVE MADE THE CASE A BASIS OF A PROPAGANDA CAMPAIGN. I REALIZE THAT A SUGGESTION THAT THE ASSASSINATION MAY HAVE ORIGINATED IN RUSSIA SOUNDS FAR-FETCHED AND IN FACT, IF IT DID NOT, I WOULD PROBABLY NOT BE WRITING YOU THUS. AT ANY RATE, THE SUSPICION IS IN MY MIND, AND I CAN BE SATISFIED ONLY BY COMMUNICATING IT TO YOU.

IF THERE IS ANYTHING ALL TO MY SUSPICIONS, THERE WILL BE MORE DEVELOPMENTS IN THE RUSSIAN CAMPAIGN TO GET A MAXIMUM OF PROPAGANDA VALUE FROM THE CASE. IT WOULD SEEM TO ME THAT, AT SOME POINT, THEY WILL WANT TO BRING THE WIDOW OF OSWALD TO RUSSIA SO THAT STATEMENTS CAN BE ATTRIBUTED TO HER DISPARAGING THE UNITED STATES. ALSO, IT WOULD SEEM TO ME QUITE LIKELY THAT THEY WILL, IN THE EVENT THAT RUBY BECOMES AVAILABLE, TRY TO BRING HIM TO RUSSIA FOR A SIMILAR REASON.

PLEASE KEEP IN MIND THAT I HAVE NO KNOWLEDGE OF THE CASE EXCEPT FROM NEWSPAPERS, TELEVISION AND RADIO. ALSO, I AM SOMEWHAT EMBARRASSED TO BE SO PRESUMPTIVE IN PASSING THIS ON TO YOU, BUT I FEEL THAT I MUST DO IT.

IF THE DOCUMENTS PLACED IN YOUR HANDS BY THE RUSSIANS PURPORT TO BE ORIGINALS, THE SCIENTIFIC DETERMINATION OF THE AGE OF EACH ENTRY, IF POSSIBLE, WOULD PROBABLY PROVIDE USEFUL CLUES.

I WILL DESTROY MY COPY OF THIS COMMUNICATION AS WELL AS THE TAPE USED IN TRANSMITTING IT AND IT WILL NOT BE NECESSARY AS FAR AS I AM CONCERNED, FOR YOU TO ACKNOWLEDGE IT OTHER THAN THAT I WOULD LIKE AN ASSURANCE NOW THAT THE TRANSMISSION WAS LEGIBLY RECEIVED BEFORE DESTROYING THE TAPE. GA PLS
