UNSUB, THREAT AGAINST PRESIDENT JOHN F. KENNEDY, NOVEMBER EIGHTEEN, SIXTYTHREE., THREAT AGAINST THE PRESIDENT.

AT TWO FIFTYEIGHT P.M., THIS DATE, MR. DANNY CRONIN, CRONIN-S CORNER, INC., THREE SIX TWO FOUR NORTH BROADWAY, GROVE CITY, OHIO, TELEPHONICALLY ADVISED THAT A PERSON DESCRIBED AS WHITE, MALE, FIVE FT., EIGHT INCHES, ONE HUNDRED SIXTYFIVE TO ONE HUNDRED SEVENTY POUNDS, BLOND HAIR, WAS IN HIS BAR APPROXIMATELY SIX O-CLOCK A.M., NOVEMBER EIGHTEEN, LAST, MAKING THREATS AGAINST PRESIDENT KENNEDY. UNSUB SAID TERRIBLE THINGS ABOUT THE PRESIDENT, THAT HE SHOULD BE HUNG, THAT HE WAS TAKING HIS ORDERS FROM THE POPE. UNSUB REPORTEDLY FROM CANTON, OHIO, AND HAS SAID HE ATTENDED COLLEGE BUT FOR SOME REASON WAS THROWN OUT. CRONIN ADVISED UNSUB PREVIOUSLY HAD BEEN IN BAR AND DID NOT HAVE MONEY BUT ON THIS OCCASION HAD PLENTY OF MONEY. UNSUB KNOWN TO HAVE AT ONE TIME BEEN EMPLOYED BY CURLEY PHACKER WHO IS PRESENTLY EMPLOYED BY MILLER CONSTRUCTION COMPANY, COLUMBUS, OHIO. CRONIN ADVISED UNSUB QUOTE IS NUTTY BUT AN INTELLECTUAL NUT UNQUOTE.
