INVESTIGATION AT FLORIDA STATE PRISON INDICATES CELL MATES
OF JOHN EMIL FREEMAN IN ADDITION TO WILLIAM DEAN WERE EMMETT
KESSELEP, CHARLES MULALLY, AKA DOC, AND HOWARD HOSKINS.
KESSELEP INTERVIEWED AT FLORIDA STATE PRISON. STATED FREEMAN
VIOLENT IN HIS LANGUAGE AGAINST PRESIDENT KENNEDY AND SAID
HE WOULD HELP CUBA ALL HE COULD UPON HIS RELEASE. HE NEVER MADE
DIRECT THREATS AGAINST KENNEDY OR COMMENTED RE POSSIBILITY OF
ASSASSINATION OR LOCATION. WHILE INCARCERATED, DEAN AND FREEMAN
EXCHANGED BLOWS OVER FREEMAN'S PRO CASTRO REMARKS. OTHER MATES
CONSIDERED FREEMAN AS POSSIBLE PSYCHO IN VIEW OF HIS TALES OF
FLYING TO AND FROM CUBA. KESSELEP RECALLS NO INCIDENTS WHICH
