 SEVEN THIRTYFOUR P.M.

ANGEL MARTINEZ JUAREZ, JUAREZ CUSTOMS OFFICIAL WHO OVERHEARD
 STATEMENTS OF /FNU/ QUIROGA AT MEXICAN BORDER NIGHT OF ASSASSINATION,
 IDENTIFIED AND LOCATED NIGHT OF NOVEMBER THIRTY LAST, AT WHICH TIME HE
 STATED QUIROGA HAD BEEN HEARD BY HIM TO MAKE STATEMENT THAT HE HAD BEEN
 IN DALLAS, TEXAS, NIGHT BEFORE THE ASSASSINATION. QUIROGA ASKED MARTINEZ
 WHY BORDER WAS CLOSED AND WAS TOLD IT WAS DUE TO KENNEDY-S ASSASSINATION
 QUIROGA THEN REPLIED THAT THEY HAD APPREHENDED A SPY IN DALLAS. MARTINEZ
 SAID QUIROGA HAD NOT MADE STATEMENT THAT HE, QUIROGA, HAD KNOWN THE
 NIGHT BEFORE THAT THE ASSASSINATION WAS GOING TO TAKE PLACE. MARTINEZ
 SAID HE WONDERED HOW QUIROGA KNEW THAT A SPY HAD BEEN APPREHENDED IN
 DALLAS AND, FOR THAT REASON, ADVISED A MEXICAN IMMIGRATION OFFICER
 OF ABOVE. MARTINEZ SAID THE MEXICAN IMMIGRATION OFFICER WHO RELATED
 ABOVE INFO TO U. S. BORDER PATROL MUST HAVE MISQUOTED MARTINEZ BECAUSE
