WEBB INTERVIEWED AND STATES AT TIME OF ASSASSINATION OF  
PRESIDENT <sup>John F</sup> KENNEDY HE WAS IN MERIDIAN, MISSISSIPPI. THIS WAS  
CONFIRMED BY HIS FATHER WHO WAS INTERVIEWED INDEPENDENTLY. DOES NOT  
KNOW PRESIDENTS ASSASSIN. WAS AT ONE TIME ASSOCIATED WITH A GROUP  
OF CUBAN REVOLUTIONARIES FOR WHO HE CONTACTED VARIOUS MANUFACTURES  
OF ARMS AS TO AVAILABILITY OF TANKS, ETC. HOWEVER NO ARMS WERE  
PURCHASED. KNOWS OF NO GROUP WHO ADVICATED KILLING THE PRESIDENT  
AND OVER HEARD IN A RESTAURANT IN MIAMI SOME MONTHS AGO FROM  
PERSONS UNKNOWN THAT TWENTYFIVE TO FIFTY THOUSAND DOLLARS WAS  
BEING OFFERED TO ASSASSINATE THE PRESIDENT.
