On 12/9/63, ELSIE BERNARD, 523 Galveston Avenue, and PETE BLANCHARD, 440 6th Street, WALTER M. BUHEL, 440 6th Street, advised that they were former acquaintances of JOHN ERNEST KING who left Port Arthur, Texas, after retiring as a merchant seaman in March, 1963, and they believe he is presently residing at 218 Market Street, Marcus Hook, Pennsylvania.

They advised that they know nothing unfavorable concerning KING and that they believe him to be a person of good moral character, a loyal citizen and one who associates with people of good reputation.

On 12/9/63, BEN JOHNSON, Secretary, National Maritime Union, 330 6th Street, advised that J. E. KING, Z #57574-D, born 3/1/98, retired as a merchant seaman in March, 1963, and all records concerning him are located at the National Maritime Union Pension Welfare, 346 West 17th Street, New York, New York.
