ON AUGUST TEN LAST, LEE HARVEY ^{deceased} OSWALD, ^{La Texas} WAS INTERVIEWED BY LT. FRANCIS L. MARTELLO, NOPD, DURING WHICH INTERVIEW MARTELLO EXAMINED ITEMS CONTAINED IN OSWALD/S WALLET. INCLUDED AMONG ITEMS WAS A PIECE OF PAPER CONTAINING WHAT APPEARED TO BE WRITING IN RUSSIAN AND IN ENGLISH. AMONG VARIOUS ITEMS WRITTEN ON THIS PAPER WAS THE FOLLOWING IN ENGLISH QUOTE UNITED PRESS SEVEN TWO SIX SIX EIGHT ONE GOLDBERG AND MOSEY UNQUOTE. IN ADDITION IS A NOTATION QUOTE ASS. PRESS. SEVEN SEVEN SIX FOUR THREE ZERO JOHNSON UNQUOTE.

INQUIRY IN NEW ORLEANS, UPI AND ^{NY} BUREAUS, HAS FAILED TO DEVELOP ANY INFORMATION CONCERNING THE NAMES OF GOLDBERG, MOSEY AND JOHNSON.
