Per CIA letter 9/23/67

1. THE AMERICAN EMBASSY IN STOCKHOLM, SWEDEN, RECEIVED A LETTER DATED 25 NOVEMBER 1963 IN STOCKHOLM CONCERNING THE ASSASSINATION OF PRESIDENT KENNEDY WAS ARRANGED BY THE ASSASSIN. THE LETTER PURPORTS TO BE FROM ONE RYO LIANG YUAN OF THE AMERICAN EMBASSY IN STOCKHOLM, BUT NO SUCH OFFICIAL IS KNOWN TO HAVE BEEN EMPLOYED THERE. IS NO RECORD OF A CHINESE CONSUL IN STOCKHOLM.

2. THE LETTER IS WRITTEN IN BROWN INK ON A YELLOWED PAPER. CHINESE CHARACTERS ARE IN CONTACT WITH THE AMERICAN CONSUL IN SOVIET UNION. WHEN OSWALD RETURNED TO AMERICA IN THE FALL OF 1963, HE RE-CONTACTED WEM, THREATENED TO EXPOSE HIM IF HE DID NOT COOPERATE.

THE RED CHINESE EXPECTED THAT THE U.S. WOULD ATTACK CUBA WHEN IT LEARNED THAT THE ASSASSIN WAS A CUBAN SYMPATHIZER. THE SOVIETS WOULD THEN ATTACK THE U.S.A., THE RED CHINESE WOULD ASK THE SOVIETS FOR ATOMIC WEAPONS, THE COMMUNIST BLOC WOULD WIN THE WAR, THE CHINESE REDS WOULD THEN ASSASSINATE KHRUSCHEV AND TAKE OVER CONTROL.

3. THE WRITER SAID HE WORKED FOR THE "DEPARTMENT OF STATE SECRET," BUT NO DEPARTMENT BY THIS NAME IS KNOWN IN THE CHINESE COMMUNIST GOVERNMENT. OUR [REDACTED] JUDGES THIS TO BE A CRANK LETTER. THE ORIGINAL LETTER IS BEING SENT HERE FOR ANALYSIS.
