Purge List "Investigation Commission of Kennedy Killings

Lyndon B. Johnson has appointed a "Top Level" Commission to investigate the Kennedy killings. Except for Senator Cooper and Congressmen Boggs and Ford, about whom I know little, who are used merely for window-dressing and who, for their own security, should take themselves out of this conspiracy, the members named, and their collaborationists, are deeply involved in the killings and would necessarily be placed on any honest "Purge List" designed to restore constitutional government in the United States. I present the briefest biographical data on these individuals to open a line of necessary inquity for a true investigation.

"Prime Movers, Ex-Officio": Scoundreis Robert F. Kennedy and Mc George Bundy, who "advised" Lyndon B. Johnson on those to be selected to the committee; leaders of the White House "Rat Pack – Irish Mafia"; totally disloyal to the Constitution of the United States; yielding loyalty only to Pope Paul of the Roman Church; prime conspirators with John F. CONCLUSIONS: The clear purpose of this fraudulent, scoundres, Commission is to conceas, not to teveall - to block all possibility of open investigation - of the crimes surrounding the Kennedy kill-lings.
