GEORGE HEIDEL, former resident of White Plains, New York, advised he was not acquainted with LEE HARVEY OSWALD and had never had any contact with OSWALD. HEIDEL said he had never been in Dallas or Fort Worth, Texas and had resided in El Paso, Texas, since December, 1962. HEIDEL's residence in El Paso verified.

GEORGE HEIDEL, owner, Sinclair Gas Station, 6354 North Mesa, El Paso, furnished the following information:

HEIDEL formerly resided in White Plains, New York. He has resided in El Paso, Texas since December, 1962. HEIDEL resided in Houston, Texas for a period of about six months prior to moving to El Paso, Texas. HEIDEL resided in White Plains prior to moving to Houston. HEIDEL has never been in Dallas or Fort Worth, Texas. He is not acquainted with LEE HARVEY OSWALD and never had any contact with OSWALD.
