RETELEPHONE CALL TO NY FROM BUREAU SUPERVISOR A. B. TWELVE SIXTY FOUR.

FOR INFO DALLAS, EDWARD ROZMUS, SIX THREE TWO MILTON ROAD, NEW YORK, TELEPHONED THE BUREAU APRIL TWELVE, SIXTY FOUR, AND. IDENTIFIED HIMSELF AS VETERAN WORLD WAR TWO AND A FORMER OWNER OF BAIT SHOP. ROZMUS STATED, FAMILY, NAME UNKNOWN, MOVED INTO APARTHENT OVER HIS MONTH AGO AND DESCRIBED THEM AS SUSPICIOUS AND UNSOCIABLE. ROZMUS ADVISED FAMILY WAS FROM TEXAS AND THAT WIFE MENTIONED SHE SAW EVERYTHING CONCERNING ASSASSINATION OF PRESIDENT KENNEDY IN TEXAS. ROZMUS INTERVIEWED APRIL TWELVE SIXTY FOUR AND STATED OVERHEARD WIFE OF FAMILY IN APARTMENT OVER HIS TELLING OWNER BAIT SHOP, NAME UNKNOWN, SIX THREE TWO MILTON ROAD, RYE, NEW YORK, APRIL TWELVE NINETEEN SIXTY FOUR, THAT SHE WAS IN TEXAS AND SAY EVERYTHING CONCERNING THE ASSASSINATION OF PRESIDENT KENNEDY. STATED " I HATE THOSE PEOPLE FROM TEXAS". ROZHUS GAVE NO BASIS FOR : STATEMENT AND SAID " I AM AN ADMIRER OF PRESIDENT KENNEDY AND WOULD ROZMUS POINTED OUT STATION WAGON PARKED OUTSIDE SI THREE TWO MILTON ROAD WHICH HE SAID HAD A TEXAS LICENSE AND WAS OWNE BY THE FAMILY UPSTAIRS. ROZMUS, DURING COURSE OF END PAGE ONE

INCOHERENT AT TIMES AND HAD BEEN OFVIOUSLY DRINKING. ROZMUS ADMITTED HE IS HEAVY DRINKER. OBSERVATION OF STATION WAGON, REFERRED TO BY ROZMUS REVEALED IT TO BE A STUDEBAKER STATION WAGON, COLOR BLUE, BEARING CALIF. LICENSE ONE Q ONE THREE EIGHT SEVEN THREE. MRS. JOHN ERICKSON, SIX THREE TWO MILTON ROAD, RYE ,NEW YORK RESIDES IN APARTMENT OVER ROZMUS, INTERVIEWED APRIL TWELVE, NINETEEN SIXTY FOUR: AND ADVISED HUSBAND AND FAMILY FORMERLY RESIDED NINE TWO ZERO NINE MANCHESTER STREET, HOUSTON, TEXAS, UNTIL EARLY DECEMBER, SIXTY THREE, WHEN THEY MOVED TO ONE ZERO ONE TWO TEMPLE AVE., LONG BEACH, CALIF. SHE STATED HUSBAND IS ITINERANT HOUSE PAINTER. SHE STATED DUE TO ILLNESS IN FAMILY, MOVED BACK TONEW YORK, FEBRUARY FOUR, NINETEEN SIXTY FOUR. MRS. ERICKSON STATED SHE AND FAMILY WERE IN HOUSTON, TEXAS, ON NOVEMBER TWENTY TWO, NIETEEN SIXTY THREE, AND DID NOT WITNESS ASSASSINATION OF PRESIDENT KENNEDY. MRS . ERICKSON, ADVISED SHE HAS UNDOUBTEDLY MENTIONED TO PEOPLE SHE WAS IN TEXAS AT TIME OF ASSASSINAT INSERTS FOLLOW FOR BUT NEVER SAID SHE WITNESSED ACTUAL ASSASSINATION.
