MISCELLANEOUS - INFORMATION CONCERNING

On 5/23 and 24/64 certain technical data requested by the President's Commission in their letter dated 5/7/64 was obtained by representatives from Seat of Government.

On 5/25/64 SA LYNDALE A. SHANEYFELT personally took the movie camera of ABRAHAM ~~ZAPRUDER~~, described as a Bell and Howell Model 414 PD 8 mm Zoomatic, Serial No. AS13486, and the case for such camera for return to the FBI Laboratory which camera is to be returned to the Bell and Howell Company at Chicago, Illinois, when it has served its purposes.

On 5/25/64 SA SHANEYFELT personally delivered to the Dallas FBI Office for safekeeping the camera of MARIE ~~MUCHMORE~~, described as a Keystone 8 mm Zoom camera, Serial No. 20648, and the camera of ORVILLE ~~NIX~~, described as a Keystone Auto Zoom Model K-810 8 mm movie camera with leather carrying case, Keystone No. 702.

It is suggested the Bureau may desire to ascertain from the President's Commission if the MUCHMORE and NIX cameras may now be returned to their owners. It is pointed out that NIX has previously indicated he must have his camera on or before 6/5/64 or it will be necessary for him to rent a similar camera which rental it is understood by NIX will be paid by the President's Commission.
