POSSESSION OF MR. JOHN HAVENS, OBTAIN THE BILL AND IMMEDIATELY
SUBMIT IT TO THE LABORATORY FOR AN APPROPRIATE EXAMINATION.

NOTE: By airtel 6-23-64, Kansas City enclosed a letterhead
memorandum which stated on 6-23-64, Mr. John Havens, clerk, IGA
Store, Hugoton, Kansas, advised of the discovery of a dollar
bill in cash receipts on which was written the words "I'm
going to kill the President, Nov. 15, 1963." This was printed
on the back. The center of the bill also contained initials which
were illegible. There was no indication if this bill was
furnished to anyone as the proprietor stated he would retain
the bill until proper authorities picked it up. Information
was furnished to Secret Service Kansas City and letterhead
memorandum enclosed with referenced airtel being furnished to
Secret Service Headquarters.
