Enclosed LHM reflects investigation conducted at Austin, Texas, in an attempt to verify statement reportedly made by ROBERT STEPHEN REYNOLDS at Austin, in 1957 concerning perceptions re instant matter.

In view of the negative nature of the information furnished by Reverend O'BRIEN and Mr. MERCHANT as reflected in interviews with them, extensive investigation to locate and interview the paraplegic law student mentioned in referenced Los Angeles teletype is not being conducted by the San Antonio Division.
