Now let me tell you who I am.

I George Dewey Stewart

was born about 1 A.M. Dec. 7th 1900 in Weogufka alabama. My Grand
mother was a decendand of England Mary Jane (Riddle) Stewart. I
think her ancestars arrived in america about 1674. My Granfather's
peoples as you know came from Scotland in 1674. My Grand Mother
Grandfather and father Methodis in Religion. Grand-father and father
were Masons. They as well as I were and are Blue Blood Yankee
americans. Did and don't believe in Slavery. (abe Peoples) I myself
would like any one to check my records from birth until now. I live
up to as near as possible my Royal Blue Blood of England and Scotland
queen Mary of Scotland Elizibeth of England Sisters Stewarts before
marrige my aunts and my Loyal Blue blood of good old U.S.A.

Now in april 1961 I was a Poll Tax Paid citizen of comanche county comanche county Seat. My mailing address was Dublin Texas RFD #2. I was living on U. S. Government Property. Given Promission by High Ranking Government officials The County Sheriff game out about 8 P.M. April 15th 1961. walked on this Property with out a warrant. Said Ill have to take you in. I asked what charges. He siad several Peoples have said that you have a bad case of indigestion. I told him that he couldn't take me in on such charge. I ask him about a warrant. Siad I have one in car. But I didn't get a chance to read the warrant until I was locked up. The charge was just mental. I wasn't allowed to contact any one. Next day afternoon I was tried. The Court Room was all set when I was brought in. Tried for mental. They didn't Prove anything. So I The 6 men juror Judge just made

charge as a Hermit. I wasn't allowed to see charge. on april 18th 1961 I was brought here The State acceped this charge. My first sentence was for 90 day Maxiam. But when I had been here 90 day was supposed to have hearing July 17th 1961 Wichita Falls County Court House 9 A.M. I wasn't allowed to attend. So I was recharged Hermit. They won't tell you a thing here. But a girl friend attendant told me in Dec. 1963 what my charge was. Since I know what I am charged with They have been more strict to hold me. I have been tortured with vile medicines over dose shots Have been called vile names. Several attempts have been made to cause me to crack up. Three or four times I have been given shots that was intended to take my life. I saw one man drop dead. He was tortured called names and increased the dope until it was to much The M. S. is what they call the Hospital. Well I have known as many as four carried out dead in 24 hours. Some of them I am sure were killed from overdosage of shots and medicines our Mails are censored going out and coming in. a lot of it tampered with.

So an FBI under cover man is needed at once also an uncover U. S. Postal inspector.

Please Mr. Hoover have one of your men contact me at once. I am telling you just a few things. In over three years I have learned Plenty. I can write a large book. I Believe also that I have spotted the Chief Engineer of President Kennedys assinator. I do know why Mr. J. F. K. was murdered and this Texans are the ones that did it. If you send a D.T. he can contact me without even inquiring. There are no guards. The Main Entrance don't even have a gate. any one can drive in unquestioned. Reason of this is to make it look to Public that it is a Respectful Hospital. It is no Hospital. Nothing about it constitutional Legal woral than a cuban Prison camp. I am a Practical D. T. use and have used my talent for only my own Personal use. I am 63 years old. 5-8 height about 140 weight 40 in. shoulders 30 in waist dark bodied hair very gray now Hazel Eyes Have Vertical scar bottom at Very top of nose extends about inch toward Hair line. I wear sport Shirts Slack Pants a Base Ball cap color Black with Red Visor I Play good Solf Ball. Wear Sandals except when I Play Ball. often I dont wear any socks when I have on my Sandals. The toe on Right foot next to large toe has been amputated. Two Mexican quack Doctors here tortured it off in 1961. after I have my lunch I spend about 45 minutes in what is called the little Store. When I am in Store I sit where I can watch door and most of the Store in Side. That is why I Mentioned before that I might spot your man first. Women Ken and Kids are about 3000. I know many names and most all faces. Unitl about 6 weeks ago I wasn't allowed off ward unless in charge of an attendant. Now I am in Recreation Dept. I have out side
