FOR THE INFO OF THE SAN FRANCISCO OFFICE, A REQUEST WAS RECEIVED  
FROM THE PRESIDENT-S COMMISSION ADVISING THAT ROBERT STEPHEN REYNOLDS  
AKA STEPEN REMETA HAS REQUESTED AN OPPORTUNITY TO APPEAR BEFORE THE  
COMMISSION BASED ON ALLEGED INFO HE HAD RECEIVED RE ASSASSINATION OF  
THE PRESIDENT WHICH HE SAID WAS ESTABLISHED IN THE EARLY MONTHS OF  
FIFTY SEVEN. THE COMMISSION DESIRED REYNOLDS INTERVIEWED. THE BUREAU  
DESIRES ADDITIONAL INFO RE INDICATION OF ANY INSTABILITY RE REYNOLDS.

INVESTIGATION AT PHOENIX REFLECTED THAT ROBERT STEPHEN REYNOLDS  
OF ONE ONE ONE EIGHT THIRD STREET, SANTA MONICA, CALIFORNIA, STATED

HE SUFFERED A NERVOUS BREAKDOWN IN FIFTY THREE AND A "DOCTOR THORN" OF PHOENIX DIAGNOSED HIS TROUBLE AS SUCH. RECORDS AT THE STATE MEDICAL ASSOCIATION, SCOTTSDALE, ARIZONA, REFLECTED A DOCTOR IRVING JAMES THORNE APPLIED FOR AN MD LICENSE IN ARIZONA IN MARCH OF FIFTY THREE, BUT APPLICATION WAS NEVER COMPLETED. DOCTOR IRVING JAMES THORNE, ONE FIVE ZERO EAST FIFTY SIXTH STREET, NYC, LICENSED IN STATE OF NEW YORK AND CALIFORNIA.

DOCTOR IRVING JAMES THORN, ONE FOUR ONE EAST FIFTY SIXTH ST., CONTACTED JULY TWO SIXTY FOUR AND ADVISED THAT HE IS A GENERAL SURGEON AND HAS NEVER PRACTICED IN ARIZONA: HE STATED DOCTOR EDWARD BLANK, A PSYCHIATRIST AND A GOOD FRIEND OF HIS, WAS A PSYCHIATRIST IN ARIZONA AND HE HAD PLANNED TO GO INTO PRACTICE WITH HIM, HOWEVER, HE NEVER COMPLETED HIS APPLICATION FOR HIS MD LICENSE IN ARIZONA. DOCTOR THORNE FURTHER ADVISED THAT HE HAD NEVER TREATED ANYONE IN ARIZONA.

HE ALSO STATED THAT DOCTOR EDWARD BLANK IS A VERY NOTED PSYCHIATRIST AND IS PRESENTLY ATTACHED TO STATE HOSPITAL, STOCKTON, CALIFORNIA, AND RESIDES AT FIVE HUNDRED WEST ALPINE AVENUE, APARTMENT TWO ZERO TWO, STOCKTON, CALIFORNIA.

DOCTOR THORNE STATED THAT DOCTOR BLANK WOULD KNOW IF THERE WAS A DOCTOR THORN IN PHOENIX, ARIZONA, IN FIFTY THREE.

THE BUREAU REQUESTS THAT THIS MATTER BE HANDLED EXPEDITIOUSLY AND RESULTS BE FURNISHED PROMPTLY TO THE BUREAU BY LHM AND INSERTS FOR DALLAS. BUREAU ADVISED THAT IN VIEW OF THE FACT THAT PRESIDENT-S COMMISSION IS PRESENTLY COMPLETING THIS INVESTIGATION, THIS MATTER MUST BE HANDLED EXPEDITIOUSLY.

SAN FRANCISCO CONTACT DOCTOR BLANK AT STOCKTON, CALIFORNIA, AND ASCERTAIN IF HE CAN IDENTIFY DOCTOR THORNE.

PHOENIX RECHECK MEDICAL LICENSE RECORDS.
