On November 25, 1963 I, William D. Crowe Jr., of 828 West Idlewild Drive, Brantville, Ind., was questioned by John Joe Houlett of the United States Secret Service at my hotel, Shady Oaks Hotel, 1511 Ft. Worth Ave., Dallas, Texas. I wish to make the following statement about Lee Harvey Oswald. I arrived in Dallas, Texas on Sunday, November 10, 1963 to do a show at the Carousel Club, 1312 1/2 Commerce St. from November 11, 1963 until November 14, 1963. Sometime between November 11, 1963 and November 16, 1963 I think that I saw Lee Harvey Oswald in the Carousel Club. I think that he was one of the people in the club that assisted in my act. By this I mean that he would call out an object and would later ask me to recall the object which I would do. I do not remember what the object was that he called out as I forgot those when the act is over. Due to the dim lighting in the Carousel Club I cannot say that this was the man for sure, but after seeing his picture in the paper it looked like him. I cannot recall for sure what night this was as I work seven nights a week and every night is like any other. Someone ask me if I had ever observed Lee Harvey Oswald and Jack Ruby talking and I wish to say that I do not recall ever seeing them talking with each other.

I wish to say that this is all that I know that may relate to Lee Harvey Oswald.

I have read and understand this statement consisting of one page, and it is true to the best of my knowledge.

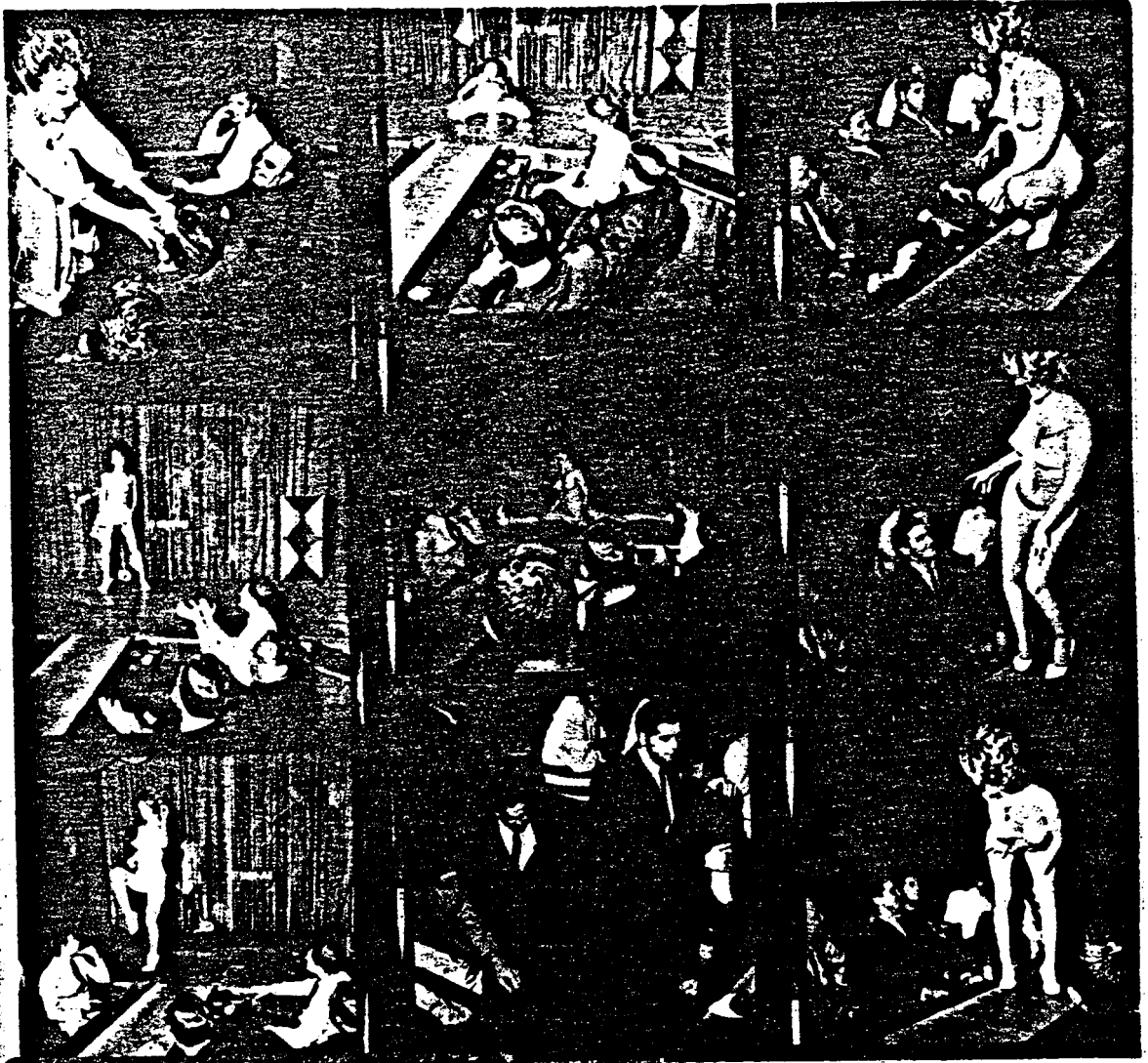
