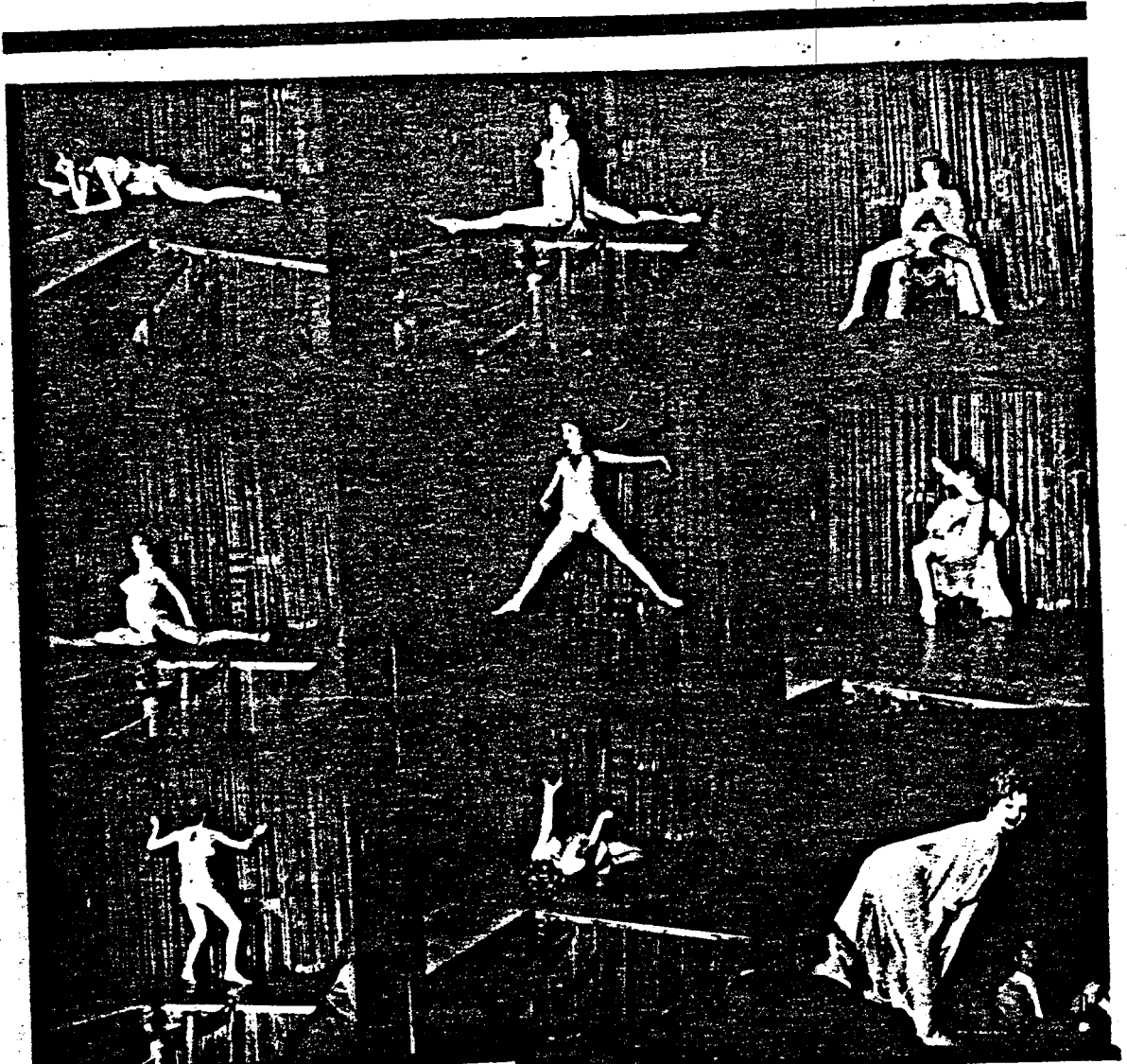
Ex.No.5303-A ARMSTRONG,A. Deposition

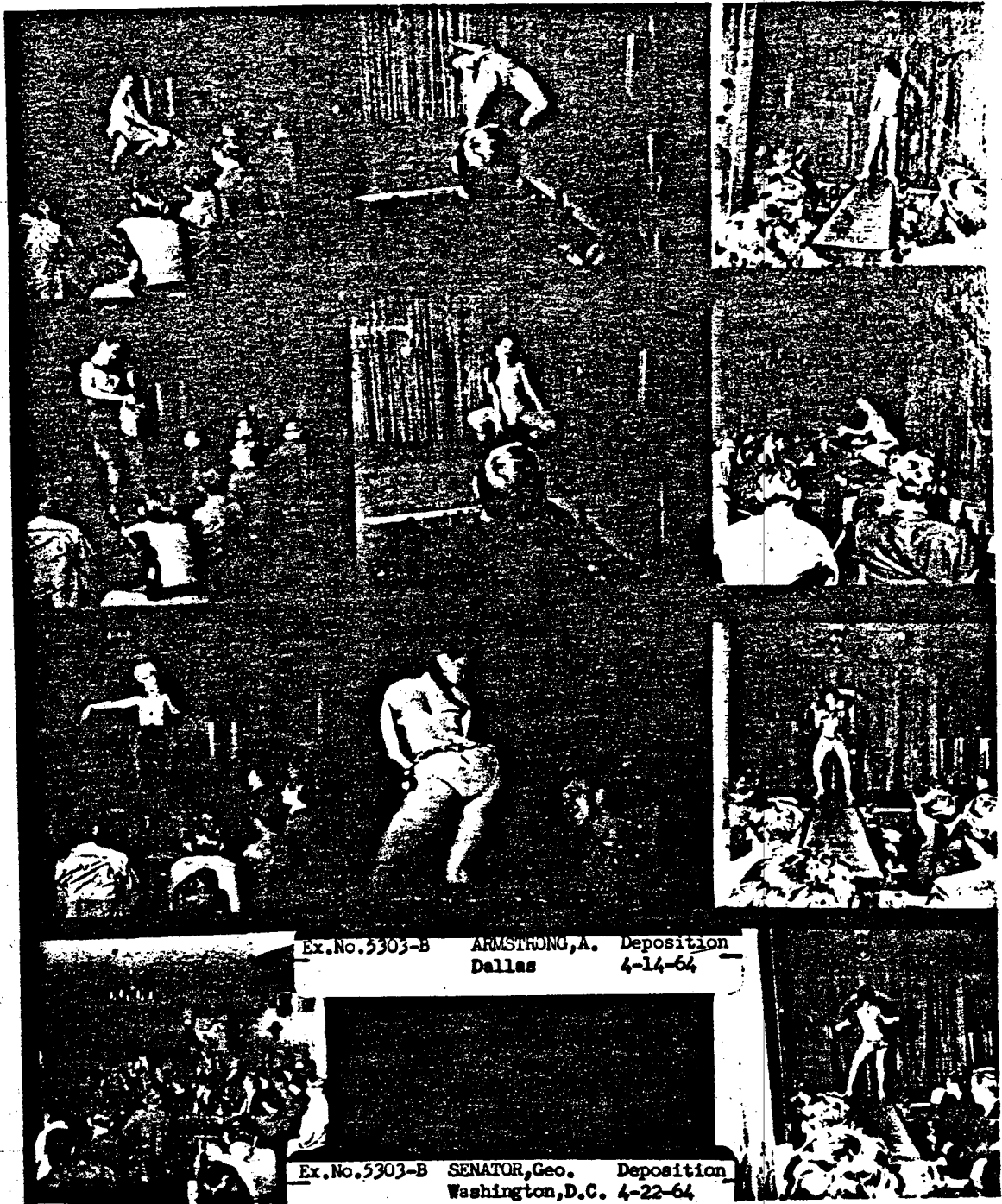
