

Holmes Exhibit 1 on application of July 23, 1964

- IMPORTANT:** Each post office box is rented with the understanding that—
1. Rent is to be paid in advance either quarterly or for a full fiscal year (July 1-June 30). Failure to pay by the first day of the period due will cause the box to be closed.
 2. The box must NOT be used for immoral or improper purposes; the conduct of a fraudulent or lottery business; the practice of deception; the conduct of any business in violation of law or delivery of mail addressed to an assumed or fictitious name. The use of the box is restricted to one individual, family, firm, or corporation, and it may serve only for the delivery of mail addressed in the name of the holder, members of his immediate family, or, in the case of a firm, each member or employee as may be entitled to receive mail therein. If any of these rules is broken the box may be closed without refund of any part of the rental.
 3. The Post Office will furnish one or two regular keys without charge, except if they are not returned when box is surrendered a charge of 50 cents each will be made. For each other additional key furnished a charge of 50 cents will be made. No refund will be made on the additional keys.
 4. Boxholder understands and agrees that all extra or replacement keys shall be obtained from the Postmaster, and under no circumstances will the boxholder or his agent obtain keys for the assigned box from any other source or supplier.



INSTRUCTIONS FOR WORKING COMBINATION BOX

1. Clear dial by three revolutions to the right, stop on 0
2. Turn dial to the left and stop the second hand around 9
3. Turn right and stop at 1
4. Turn left key LEFT to open.

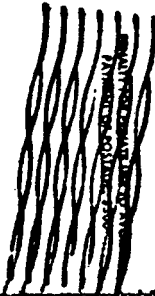
