REVILO P. OLIVER RETURNED HOME LATE AFTERNOON HOURS SEPTEMBER SIX INSTANT. HOME ADDRESS IS SEVEN ZERO ONE WEST OHIO STREET,

URBANA, ILLINOIS, TELEPHONE NUMBER THREE SIX SEVEN DASH ONE SIX SIX

ZERO. OLIVER EXPRESSED COMPLETE WILLINGNESS TO TESTIFY BEFORE WARREN COMMISSION. REQUESTED OPPORTUNITY TO ASSEMBLE NECESSARY MATERIAL FOR TESTIMONY AND TIME TO CONSULT ATTORNEY. STATED HE WOULD PREFER NOT TO APPEAR BEFORE COMMISSION BEFORE SEPTEMBER ELEVEN NEXT.

USM, DANVILLE, ILLINOIS BY JENNER FOR SERVICE ON OLIVER. OLIVER AGREED TO MAKE HIMSELF AVAILABLE FOR SERVICE OF SUBPOENA
