marks were placed around "Harry."

Your attention is invited to Page 4, of rerep
relating to an alleged threat against Senator Everett H.
Dirksen of Illinois. Upon receipt of this information
Senator Dirksen's Office, Capitol Police and local Washington,
D. C., police were notified. This information was also
furnished to the U. S. Secret Service.

Provided all corrections referred to above have been
made authority is granted for Dallas to disseminate one
copy of rerep to U. S. Secret Service locally.

For the information of Dallas, two copies of
rerep were furnished to the President's Commission and
one copy each was furnished to the Department of Justice
and U. S. Secret Service Headquarters Washington, D. C.

The referenced 57 page report is the eighth such report received at the Bureau containing the results of investigation relative to allegations against persons other than Lee Harvey Oswald since the assassination. The information relates to remarks and threats allegedly made by individuals concerning their feelings about President Kennedy, other officials and the policies of the administration. The complaints are initiated by cranks, mental cases and patriotic citizens. Copies of this report have been disseminated to the President's Commission, the Department and Secret Service.

Dallas in the cover pages accompanying rerep requested Bureau authority to disseminate copy of this report locally. In view of this request, above communication is being sent.
