Mr. SCHILLER said he believed he has additional information concerning some homosexual aspects of the individuals involved or mentioned in the investigation of the KENNEDY assassination, but prior commitments on Harch 16, 1967, precluded him from discussing the matternial further. He said he will furnish this information at a later date. He mentioned information concerning alleged lesbian relationship between MARINA OSMALD and RUTH PAYNE TABLE and alleged homosexual relation between LEE HARVEY OSWALD GROWN IN EACH OF THE AYNE'S husband.
