It appeared that he wanted to criticize the Bureau because he imagined that he had not been received in alleged previous contacts with the Bureau in a manner consistent with his exalted position of retired colonel, USA. In this respect he made what he admitted were facetious comments critical of the Director and the FBI which he thought would prove the objectivity of his information. He said he wrote a poem critical of the Director about wiretapping which no one would publish, except possibly the radical papers which he had no intention of approaching. was told that his attempts at such humor were not appreciated and personally offensive. He said he appreciated the expressed forthrightness and meant no deprecation of the Director and his fine record; that he was only being facetious.
