ASSASSINATION OF PRESIDENT JOHN F. KENNEDY.

REFERENCE NEW YORK

RENY TELEPHONE CALL TO BUREAU, THIS DATE.

WILLEM L. OLTMANS, CREDITED DUTCH CORRESPONDENT IN THE US AND PRESENTLY REPRESENTING NETHERLANDS TELEVISION COMPANY (NTS), HOLLAND

ADVISED THIS DATE, THAT INFORMATION RECEIVED AT NTS FROM AN INFORMANT

IN WESTERN EUROPE THAT GEORGE DE MOHRENSCHILDT WAS THE PRINCIPAL ORGANIZER IN THE ASSASSINATION OF PRESIDENT KENNEDY. DIMITRI

MOHRENSCHILDT, BROTHER OF GEORGE, ALLEGEDLY WAS A PARTICIPANT IN THIS PLOT, AND WAS POSSIBLY THE SECOND ASSASSIN WHO FIRED FROM THE WOODS SIMULTANEOUSLY WITH OSWALD.

AN UNKNOWN INDIVIDUAL WAS SECOND IN COMMAND TO GEORGE DE MOHRENSCHILDT AND WAS IN THE HOTEL BAKER, FOURTH FLOOR, CORNER ROOM, FOR SEVERAL DAYS PRIOR TO NOVEMBER TWENTY THIRD NINETEEN SIXTY THREE, AND DIRECTED THE ASSASSINATION. THIS INDIVIDUAL IS DESCRIBED AS WHITE MALE, SHORT, FAT, DARK BALDING HAIR, CONTINUALLY SMOKES CIGARS.

NETHERLANDS TELEVISION COMPANY

CAREL ANKELLAAR, CHIEF OF PROGRAMS, NTS, HOLLAND, HAS INSTRUCTED OLMANS TO PROCEED TO DALLAS TO VERIFY CERTAIN ASPECTS OF THE STORY. OLMANS HAS BEEN IN DALLAS AND HAS ARRANGED UNDER PRETEXT, FOR A TELEVISION INTERVIEW OF GEORGE DE MOHRENSCHILDT ON APRIL TWELFTH OR APRIL FOURTEENTH NEXT IN DALLAS.

ANKELLAAR POINTED OUT TO OLMANS, THIS DATE, THAT INTERVIEWS IN DALLAS ARE POTENTIALLY DANGEROUS TO HIM AND SUGGESTED THAT HE CONTACT SENATOR KENNEDY FOR PROTECTION. OLMANS DID NOT ANTICIPATE THAT THIS MATTER WOULD BE REFERRED TO THE FBI BY SENATOR KENNEDY'S OFFICE AS IT WAS, SINCE HE IS APPREHENSIVE ABOUT THE PREMATURE DISCLOSURE OF THE FACTS BEFORE THE RELEASE OF STORY BY NTS. OLMANS ASKED FOR PROTECTION BY FBI WHILE IN DALLAS, AND INDICATED HE WOULD LIKE THE FBI TO ASSIST HIM IN HIS INVESTIGATION IN DALLAS. OLMANS WAS ADVISED THAT THE FBI COULD NOT OFFER PROTECTION AND IT WAS SUGGESTED THAT HE OBTAIN PROTECTION FROM THE LOCAL POLICE DEPARTMENT OR FROM A PRIVATE BODYGUARD IF HE FELT SUCH WAS WARRANTED.

OLMANS WAS UNWILLING TO DIVULGE ADDITIONAL INFORMATION AT THIS TIME. HE INDICATED THAT HE HAD SUFFICIENT INFORMATION TO RELEASE HIS

STORY TO THE PUBLIC VIA TELEVISION IN TWO OR THREE WEEKS, BUT THE INTERVIEW WITH HIM DID NOT INDICATE THAT HE HAD <sup>ANY</sup> EVIDENCE TO CORROBORATE THE INFORMATION SUPPLIED BY THE INFORMANT IN EUROPE.

OLTMANS STATED HE WILL CONTACT ~~HIS~~ <sup>NETHERLANDS TELEVISION CO</sup> IN HOLLAND FOR FURTHER INFORMATION WHICH THEY FEEL COULD BE SUPPLIED TO THE FBI AT THIS TIME. NO FURTHER CONTACT WILL BE MADE WITH OLTMANS, BUT IT WAS POINTED OUT TO HIM THAT THE <sup>NEW YORK OFFICE</sup> NYO WILL TAKE ANY INFORMATION THAT HE HAS TO OFFER.
