Several days later, a person who attended this meeting was interviewed by FBI Agents of the Los Angeles Office and related what he had heard at Churchill Farms. The names of the Agents are known to the author. This is the extent of the paragraph concerning the assassination of John P. Kennedy.

REID said that his informant was reliable over the years and related this story to him about 18 months ago. After leaving New Orleans his informant traveled to Dallas and then to Los Angeles and several days later was interviewed by Bureau Agents concerning the BILLIE SOL ESTES case and allegedly related the incident at Churchill Farms. He refused to identify his informant, but said he would contact his source and see if his source was agreeable to making his name available to the FBI. The names of the Agents as furnished to REID by his informant were JIM ELDRIDGE and L. BLANTON.

On 5/10/67, REID advised that he again contacted his informant to determine if he was agreeable to having his identity revealed by REID to the FBI. According to REID, the informant refused and persisted in his story.

REID declared that, although the FBI states that this information was not received from his informant, he will leave the story stand as is and that the book is now in the hands of his publisher.
