THE TIMES PICAYUNE, ^{Daily News paper,} JUNE TWENTYTWO INSTANT REPORTED
THAT THE NASHVILLE TENNESSIAN, ^{Daily Newspaper,} QUOTED DISTRICT ATTORNEY JIM
GARRISON AS SAYING PRESIDENT JOHN F. KENNEDY WAS KILLED BY
A FOURTEEN-MAN TEAM OF CUBAN GUERRILLAS WHO TRAINED SECRETLY
IN ST. TAMMANY PARISH IN THE SUMMER OF SIXTYTHREE. ACCORDING
TO THE ARTICLE, GARRISON BELIEVES THE ASSASSINS WERE ANTI-
CASTRO REFUGEES BROUGHT TO NEW ORLEANS FROM MIAMI TO PREPARE
FOR AN ASSAULT ON CUBA.

GARRISON WAS ALSO QUOTED AS SAYING THE LATE DAVID
FERRIE WAS CONNECTED "IN SOME CAPACITY" WITH THE GUERRILLAS.
GARRISON ALSO ALLEGEDLY SAID THE MEN HE NOW SEEKS IN HIS
PROBE WERE "DEFINITELY AMONG THE CUBAN TRAINEES".

THE TENNESSIAN SAID GARRISON THEORIZED THAT "SOME 16 JUN 28 1967
MEMBERS KNOWN TO FERRIE TURNED THEIR WRATH ON PRESIDENT

NEW ORLEANS STATES-ITEM, RED FLASH EDITION, JUNE TWENTYTWO INSTANT, REPORTED THE NEW ORLEANS METROPOLITAN CRIME COMMISSION IN AN EIGHT-PAGE LETTER TO LA. ATTORNEY GENERAL JACK P. F. GREMILLION CALLED ON THE ATTORNEY GENERAL TO LAUNCH AN EXHAUSTIVE INVESTIGATION INTO THE MANNER IN WHICH DISTRICT ATTORNEY GARRISON IS CONDUCTING HIS KENNEDY DEATH PLOT PROBE. THE CRIME COMMISSION SAID IT WANTS GREMILLION TO SELECT A BLUE RIBBON COMMITTEE TO NAME A SPECIAL PANEL OF THREE INVESTIGATORS. *Law*

THIS SAME ISSUE OF THE NEWSPAPER REPORTED THAT DISTRICT ATTORNEY GARRISON REACTED TO THE METROPOLITAN CRIME COMMISSION'S CALL FOR A STATE INVESTIGATION OF HIS OFFICE BY CHALLENGING THE MANAGING DIRECTOR AARON KOHN TO TAKE HIS CHARGE BEFORE THE ORLEANS PARISH GRAND JURY. GARRISON WAS QUOTED AS SAYING HE WOULD ASK FOREMAN ALBERT V. LABICHE TO CALL KOHN BEFORE THE GRAND JURY SO THAT HE CAN PRESENT HIS CHARGES THERE. *Law*
