Lawrence Jay Rosenblatt Protection of the President

On July 7, 1967, Inspector William D. Wallace, United States Immigration and Naturalization Service, Montreal, - Canada, telephonically advised Special Agent James B. Colby, New York Office, Federal Bureau of Investigation, that Lawrence Jay Rosenblatt arrived in Montreal on July 7, 1967, from New York. Rosenblatt was examined by Canadian medical examiners and adjudged insane. Rosenblatt was ordered out of the country and was put on Air Canada Flight Number 2770, due to arrive in New York at Joim F. Kennedy Airport at approximately 10:15 p.m., July 7, 1967.

Inspector Wallace advised he interviewed Rosenblatt who stated that he came to Canada to "prevent Bobby Kennedy from being assassinated". Rosenblatt stated that President Johnson "was guilty of the most heinous crime, the assassination of President Kennedy". Wallace advised that Rosenblatt referred to President Johnson as a "modern day Hitler".

Wallace stated that, Rosenblatt was born on April 24, 1948, in Bronx, New York, and resides at 170-44 130th Avenue, Jamaica, Queens, New York, and his father is Max Rosenblatt.

Laurence Jay Rosenblatt

On July 7, 1967, at 11:15 p.m., Patrolman Robert Merz, Port Authority Police, John F.Kennedy Airport, telephonically advised Special Agent James B. Colby that Rosenblatt arrived at John F. Kennedy Airport aboard Air Canada Flight Number 2770, at approximately 10:45 p.m., where he was met by a Customs Agent and a Secret Service Agent who escorted him to the Air Canada Station Manager's office for interview.

At 2:30 a.m., July 8, 1967, Special Agent James Heavey, Secret Service, New York City, telephonically advised Special Agent Edward J. O'Malley that he interviewed Rosenblatt at John F. Kennedy Airport and that Rosenblatt was not in control of his mental facilities. Rosenblatt claimed that President Johnson was responsible for the assassination of President Kennedy. Heavey advised that he accompanied Rosenblatt and his parents to Elmhurst General Hospital, where he was committed as a schizophrenic paranoiac.
