ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY NOVEMBER 22,1963, DALLAS, TEXAS

The following investigation was conducted on July 11, 1967, by Special Agents Malvin Lee Wessel and John T. Mc Carrier at Minocqua, Wisconsin:

Assassination of President John F. Kennedy, November 22, 1963, Dallas, Texas

Phyllis Mary Nackman, fifty-three years of age, with home address Route 1, Box 14, Minocqua, Wisconsin, was contacted and advised that she and her husband, Albert Joseph Nackman, are the owners and operators of Cabby's Shell Service, Minocqua, Wisconsin.

Mrs. Nackman advised that her maiden name was Schultz and that her brother, now deceased, was Phillip James Schultz.

Mrs. Nackman advised that she and her brother were mistaken for twins when he was living but she advised that he was fifty-six years of age when he died in 1965.

Mrs. Nackman stated that she and her brother had been raised in Hammond, Indiana, and that her brother had worked for the B & O Railroad at East Chicago, Indiana until he left that area in 1954. She stated that he left due to the fact that he was angry at his employers and that she did not hear from him for approximately three years. She stated that she received a letter from him in 1957, advising that he was working as a bartender at that time in New Orleans, Louisiana.

Mrs. Nackman stated that thereafter she saw her brother on one occasion, June 25, 1963, when he traveled to Minocqua, Wisconsin, for her twenty-fifth wedding anniversary. She stated that thereafter he returned to New Orleans, Louisiana.

She stated that she did not correspond with her brother on a regular basis and that in the latter part of July, 1965, she received a telephone call from a man who identified himself as Gene Davis from New Orleans, Louisiana. She stated that Davis identified himself as a friend of her brother's and that Davis advised her that her brother was in the Charity Hospital in New Orleans in very ill health and close to dying.

Mrs. Nackman advised that she traveled to New Orleans, Louisiana, and was with her brother when he died on August 8, 1965. She stated that a tube leading to the bladder burst which caused Assassination of President John F. Kennedy, November 22, 1963, Dallas, Texas

her brother's death, along with the fact that he was a diabetic and a bleeder.

She stated that in New Orleans she met the man who identified himself as Gene Davis who stated that he was a close friend of her brother's and who at times had lived with her brother as a roommate. She described Davis as a male Caucasian, approximately fifty-seven years of age, five feet four inches tall, slender build, with dark, wavy hair.

Mrs. Nackman stated that to her knowledge her brother had never been in any trouble, did not have any criminal or mental record, and had never married.

Mrs. Nackman stated that to her knowledge her brother never used any names other than his own and that the names of Clem or Clay Bertrand were unknown to her.

Mrs. Nackman further advised that she did not keep track of her brother in New Orleans, Louisiana, and that Gene Davis was the only person known to her with whom her brother associated in New Orleans. She advised that she believes the last address she had for Davis was 524 Bourbon or 524 Dolphin Street, but advised that she was reciting these addresses from memory.
