1. HAROLD CITRYNELL, BORN NEW YORK, NY MARCH 10, 1923, BEARER US PASSPORT D757574 ISSUED NOVEMBER 7, 1963 NEW YORK, CALLED AT EMBASSY STOCKHOLM JUNE 26 TO RENOUNCE FORMALLY US CITIZENSHIP. CONSULAR OFFICER ASKED HE CONSIDER SERIOUSNESS ACT OVERNIGHT BUT HE REAPPEARED JUNE 27 DETERMINED TO RENOUNCE.

2. IN A WRITTEN STATEMENT CITRYNELL CLAIMS HIS CONSTITUTIONAL RIGHTS BEING VIOLATED BY US SECRET AGENCIES INCLUDING FBI AND CIA. AMONG OTHER THINGS, CLAIMS TAMPERING WITH HIS MAIL, ILLEGAL SEARCHES, ENTRY INTO HIS HOME AND PHYSICAL ABUSE. DURING COURSE PROLONGED INTERVIEW STATED HE HAS BEEN ACCUSED BEING INVOLVED ASSASSINATION PRESIDENT KENNEDY BECAUSE HE EMIGRATED USSR FOR TWO YEARS 1958-59 WITH WIFE AND SMALL CHILD. UPON RETURNING US WIFE DIVORCED HIM AND SHE HAS CUSTODY CHILD. SAYS HE UNABLE HOLD JOB IN US BECAUSE OF INTERFERENCE BY INTELLIGENCE AGENCIES. HAS BEEN LIVING ZURICH PAST YEAR BUT ARRIVED SWEDEN MONTH AGO IN SEARCH OF JOB, BUT HE SAYS CANNOT GET WORK PERMIT WHILE IN SCANDINAVIA. HE CLAIMS TO BE CONSULTING ENGINEER. ALTHOUGH DISTRAUGHT, HE APPEARS MENTALLY COMPETENT.

3. CITRYNELL WILL CALL AT EMBASSY JUNE 30 TO COMPLETE FORMAL RENUNCIATION ACCORDANCE SECTION 349(A)(6). REQUEST GUIDANCE INCLUDING ANY BACKGROUND INFORMATION AVAILABLE.
