Re: KENNEDY ASSASINATION TROPUS

On July 11, 1967, THOMAS V. MULLEN, Operations Officer, Intelligence Corps Detachment, Fort Monroe, Virginia, furnished the original of captioned post card to SA JOSEPH L. TIERNEY advising that it had been received by the Signal Officer at Fort Monroe, Virginia, by regular mail, and had been referred to his office for appropriate action. MULLEN stated that he had the name D. E. HARE checked with the Military Intelligence Group covering the New York City area, and no record of any such individual was in their files.

MULLEN stated that neither the Signal Officer nor personnel available to him in the Intelligence Corps were able to explain in any way the significance of the inscriptions on the post card, particularly the address on the rear of D. E. HARE, in care of BRIGGS at the U. S. Secret Service in New York. He stated that he was furnishing it to the Federal Bureau of Investigation as the federal agency having jurisdiction under law in cases of assassination of a President, for whatever action they might deem appropriate.

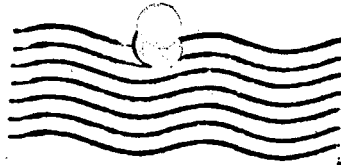
