EIGHTEEN PERSONS HAVE BEEN SUBPOENAED AS STATE WITNESSES IN  
THE AUGUST NINE TRIAL IN CRIMINAL DISTRICT COURT OF DEAN A. ANDREWS,  
ATTORNEY ACCUSED OF PERJURY BEFORE THE GRAND JURY INVESTIGATING  
AN ALLEGED CONSPIRACY TO KILL PRESIDENT JOHN F. KENNEDY.

THE TRIAL IS SCHEDULED BEFORE JUDGE FRANK J. SHEA BEGINNING  
AUGUST NINE.

USA LOUIS C. LACOUR ADVISED AT FOUR P.M. THIS DATE THAT NO  
SUBPOENAS HAD BEEN LEFT AT HIS OFFICE FOR EITHER ASA KENNEDY OR  
JENSEN.

HE ADVISED THAT THERE HAD BEEN HAND DELIVERED TO HIM LATE  
THIS AFTERNOON THE FOLLOWING LETTER FROM RICHARD V. BURNES,  
EXECUTIVE ASSISTANT, DISTRICT ATTORNEY:

"RE: DEAN A. ANDREWS, JR., VIOLATION RS 14:123

"DEAR MR. LACOUR:

"DEAN A. ANDREWS, JR. IS CHARGED WITH COMMITTING PERJURY IN  
THE ABOVE CAPTIONED MATTER WHICH IS SET FOR TRIAL IN SECTION G OF  
THE CRIMINAL DISTRICT COURT FOR ORLEANS PARISH ON AUGUST NINE,  
SIXTYSEVEN.

"IN PRESENTING ITS EVIDENCE OF PERJURY BY THE DEFENDANT OUR  
OFFICE REQUIRES THE TESTIMONY OF EITHER ONE OR TWO FBI AGENTS,  
SPECIAL AGENT REGIS KENNEDY AND SPECIAL AGENT REED W. JENSEN,

ACCORDINGLY, SUBPOENAS SHALL BE ISSUED REQUESTING THEIR PRESENCE IN COURT ON AUGUST NINE, SIXTYSEVEN. BY THIS LETTER OUR OFFICE IS REQUESTING THAT THESE OFFICERS BE AUTHORIZED, DIRECTED AND PERMITTED TO TESTIFY IN THIS PROCEEDING, PURSUANT TO REGULATIONS IN EFFECT IN YOUR OFFICE. THE PRINCIPAL TESTIMONY TO BE SOUGHT BY THE STATE DEALS WITH DEAN A. ANDREW'S STATEMENTS TO THESE AGENTS RELATIVE TO HIS HAVING RECEIVED A TELEPHONE CALL FROM A PERSON IDENTIFIED AS CLAY BERTRAND REGARDING DEAN ANDREW'S REPRESENTATION OF LEE HARVEY OSWALD AND THE SURROUNDING FACTS OF DEAN ANDREW'S ASSOCIATION WITH CLAY BERTRAND AS REVEALED BY DEAN ANDREW TO THESE TWO SPECIAL AGENTS.

"MUCH OF THIS MATERIAL IS COVERED IN TWO REPORTS BY THE FEDERAL BUREAU OF INVESTIGATION RELATING TO INTERVIEWS OF DEAN ANDREW ON DECEMBER THREE, NINETEEN SIXTYTHREE AND DECEMBER FIVE, NINETEEN SIXTYTHREE. THE FIRST SUCH REPORT BEARS FILE NO. EIGHT NINE DASH SIX NINE AND THE SECOND SUCH REPORT BEARS FILE NO. ONE ZERO ZERO DASH ONE SIX SIX ZERO ONE. BOTH OF THESE REPORTS HAVE BEEN

LIES SOLELY WITH THE ATTORNEY GENERAL AND HE IS FORWARDING MR.  
BURNS' REQUEST TO THE ATTORNEY GENERAL.
